Scope: SGS was engaged to test the leakage potential of flooring sample supplied.

Methodology: The sample was prepared by the client and sent to SGS. Two 5cm diameter areas (tee

and line intersection between plank) were selected and sealed off by SGS then exposed to 5cm³ water with coloured food dye and left to soak for 24 hour at 23°C and 75% R.H. No refill required if dyed water evaporated or drained. After 24 hour duration, any remaining dyed water was removed and the underside of the flooring visually inspected

for signs of leakage.

Results: No leaking was observed from the underside of the plank
