Drop Shipping Terms and Application

Please read and complete this application to set up your account for drop shipping. Applications can take up to one week to be processed. Once approved, we will be able to ship orders directly to your retail customers on your behalf.

Overview. Drop ship orders will be delivered to your retail customer at the Ship To address you provide. These packages will not contain the wholesale invoice that you normally receive with your order. Instead, your retail customer will receive a generic Packing Slip listing your company's name and the items delivered (but no pricing information). The package will not show MMA International's name or logo. We will send your wholesale invoice to the e-mail address we have on file.

Quick Delivery. Like your other MMA orders, drop ship orders are typically shipped by the following business day. Priority overnight orders placed by noon central time will ship on the same business day.

Presentation. Drop ship orders are delivered in a fabric pouch for a quality retail presentation. To see a sample or for more information on custom packaging, visit www.mmasilver.com/pages/drop-shipping.

Cost. A \$3.95 drop ship handling charge applies to all standard drop shipped orders, in addition to your shipping option rate. Customized promotional material can be added for no additional cost. That's it, there are never any hidden fees or extra charges!

How to Place a Drop Ship Order. It's simple. When ordering online, enter your retail customer's address in the Ship To fields – this is where we'll deliver the order. Leave your company's information in the Bill To fields. Then, just click the "Drop Ship" check box during checkout.

If you're sending multiple drop ship orders to different retail customers in a single day, you will enter them as separate orders. You can pay by credit card, or with an open account once a credit application is approved.

Returns. Our standard 15-day return policy applies to all drop ship orders. If an item is defective, your retail customer must first return the item to you. You can then email us for a Return Authorization Number and send the item back to us within 15 days for credit or exchange. All returns must be initiated through email.

Resale Certificate. All drop ship customers are required to complete and sign a Resale Certificate documenting that your purchases are for resale, and return this form to MMA International.

RESALE CERTIFICATE

I, the purchaser named below, claim the right to make a non-taxable purchase for the resale of taxable items described below from:

Taxable items purchased will be resold, rented, or leased by me within the geographical limits of the United States of America, its territories and possessions, or within the geographical limits of Mexico, in their present form or attached to other taxable items to be sold.

Description of items to be purchased: **JEWELRY. All purchases will be resold in the regular course of business.**

I understand that if I make any use of the items other than retention, demonstration or display while holding them for sale, lease or rental, I must pay sales tax on the items at the time of use based upon either the purchase price or the fair market rental value for the period of time used.

I understand that it is a criminal offense to give a Resale Certificate to the seller for taxable items that I know, at the time of purchase, are purchased for use rather than for the purpose of resale, lease or rental and, depending on the amount of tax evaded, the offense may range from a Class C misdemeanor to a felony of the second degree.
