Black Jack® Foundation & Roof Coating Black Jack Foundation & Roof Coating is a liquid applied, thin "paint like", asphalt based coating designed to penetrate and seal foundation block walls below grade and masonry roof surfaces. Prevents moisture from penetrating walls. Can also be used to seal and protect underground wood footings and metal surfaces.

PREP THE AREA: Remove all dust, dirt, and debris. Patch all cracks or seams with Black Jack 6230 All-Weather Roof Cement. Remove all rust or loose paint from metal surfaces. Do not apply over damp or wet surfaces. On foundations apply only over cured concrete and masonry. Not for use on sloped roofs, as product will run and drip.

HOW TO APPLY: Use brush or roller to spread across surface of foundation or roof.

COVERAGE RATE: This 5-gallon pail covers 350 - 500 sq. ft., per coat, over masonry and roof surfaces, depending on texture and porosity of surface. Two coats are recommended.

CLEAN UP: Tools should be cleaned with paint thinner or mineral spirits.

PRECAUTIONS: Protective clothing and eyewear should be used during application of these products. When transporting this product, ensure that lid is tight and pail secure and upright. Do not allow pail to tumble as this may cause lid to loosen and leakage to occur. Do not transport on passenger seats or inside the passenger compartment of any vehicle. Store product in the cargo area of vehicle, and secure over protective cloths to prevent damage due to accidental spills. Do not store at temperatures above 100 °F. This manufacturer also disclaims liability for flat surface application where poor drainage or ponding water may prevail. Do not reuse empty containers. Do not use in drinking water or food systems.
