Temporary Authority for ON & OFF-LICENCES

Pursuant to section 136 of the Sale and Supply of Alcohol Act 2012, a Temporary Authority Order has been granted by the Central Otago District Licensing Committee in accordance with the following details:

Applicant: Foley Wines Limited

Type of Licence: On & Off-licence

Premises: Located at 73 Felton Road, Bannockburn (trading as Mt Difficulty Wines)

Term of Authority: from 3 January 2019 until 4 March 2019 (On-licence)
from 3 January 2019 until 3 April 2019 (Off-licence)

Purpose:

The purpose of this Temporary Authority Order is to enable the premises to continue operations while the On & Off-licences are being applied for and considered by the Central Otago District Licensing Committee.

Conditions:

1. The licence must be operated in accordance with the provisions of the Sale and Supply of Alcohol Act 2012 and is subject to the conditions of the existing licence numbers: 67/ON/3/2016 – expiry date 4 March 2019 and 67/OFF/39/2018 – expiry date 24 January 2020.
2. Payment of any annual fee applying to licence number 67/ON/3/2016 and 67/OFF/39/2020 that is due during the period of this order.

Note: Your application for a new licence should be made at least 30 working days before the expiry of this Order.

In the event that a decision in respect of the new licence application is made prior to the expiry date of this authority, then that decision of the Central Otago District Licensing Committee or Alcohol Regulatory and Licensing Authority as the case may be, shall take precedence over the Temporary Authority Order which shall be cancelled as from the date of the decision.
