The Exhibition Expressions of Interest can be submitted to New Zealand Glassworks (NZG) at any time.

The selection of an exhibition/works deemed suitable for New Zealand Glassworks (NZG) is based on the following criteria:

- New Zealand Glassworks (NZG) is focused to exhibit, sell, promote and create new opportunities for New Zealand's leading and emerging glass artists.
- New Zealand Glassworks (NZG) is committed to showing original, high quality work that demonstrate skill in design, form, function and production.
- Contextualisation of work within the current NZG space and supported makers.
- Work will be displayed subject to space considerations and size limitations.
- All work supplied must be the guaranteed original work of the maker.
- All work is preferably made in New Zealand.
- All works are consigned to NZG and will be subject to a signed consignment contract between both parties.

C. The following Terms and Conditions are required for an exhibition:

1. A submission to NZG outlining the proposed exhibition including photos, sizes of works, number of pieces, artist/exhibition statement and any special requirements to exhibit any of the works. Artist/Exhibition Statement - Must be written in the first person ('I' and 'my' type statements) and should not include direct quotes from other sources, it is essentially a short statement about the artwork/exhibition - word limit is 150-200 words.

Once the submission is received it will be reviewed by a panel and any further requirements and/or parameters for the exhibition will be discussed with the artist directly prior to the confirmation and commencement of the exhibition.

2. The duration of the exhibition will be for 8 continuous weeks, dates for the exhibition will be discussed and confirmed between the artist and facility manager.

3. Glass component must be at least 85% of each piece.

4. Maximum weight is 10kg per piece. All works will be displayed on plinths or wall hung – if your glass is particularly voluminous you must contact NZG manager before submission to check installation space issues.

5. Complicated installation and take-down will need to be managed by the artist on a specified day or include clear instructions that staff at NZG can follow.

6. All work must be for sale. A commission of 40% will be deducted from the retail price.

7. Please ensure all artworks are packaged to a professional standard to freight. It is the responsibility of the artist to have all works insured while in transit. All costs associated with packaging, the delivery and return of unsold works is that of the artist.

8. All works will be insured by NZG during the exhibition in the gallery.

9. IMAGES:

For the purpose of exhibition promotional material NZG will require images to be used for an exhibition:

Glass artwork photo – must be of professional quality, with clear neutral background and must have clear space around edges for editing. If you cannot take good photos of your work, get a professional photographer to do so. Images taken from a Smartphone cannot be used and all images must be of professional quality. The photos must be of the entire piece and be the actual work you are exhibiting. All photos must be sent at full resolution and uploaded to Dropbox. Instructions will be emailed when requested and are easy to follow.

Photo to be labelled: Surname First Name - Glass

Artist photo – like passport. Head and shoulders against a clean neutral background. Photo quality to be same as artwork photo. Photo to be labelled: Surname First Name – Artist.

Please include all of the following items with your expression of interest:

- a current Curriculum Vitae
- an Artist/Exhibition Statement (100-300 words max.)
- a selection of high quality images of work: Number of images: 5-10
Format: .jpeg
Maximum file size: 3mb
Resolution: 300dpi (or 72 dpi – for online publication)
All images must be provided on a CD or Memory Stick or a Drop Box link can be provided on request.
- All details are complete.
