WELLVITA® CALCIUM COMPLEX (tablet)

COMPOSITION

Each tablet contains: Active ingredients: Calcium carbonate 1388 mg (equivalent to 500 mg elemental calcium), magnesium oxide 166 mg (equivalent to 100 mg elemental magnesium) and vitamin D3 400 IU.

*Tablets are sugar free.

PHARMACOLOGICAL CLASSIFICATION

D34.12: Multiple substance formulation.

Complementary medicine: Health supplement.

INDICATIONS

Calcium is a mineral that's well-known for its key role in bone health. Wellvita® Calcium Complex provides daily calcium essential for maintenance of strong bones. It's especially formulated with magnesium and vitamin D3 to help with calcium absorption.

CONTRA-INDICATIONS

Do not use this medicine if you are hypersensitive (allergic) to any of the ingredients in the formulation. Not suitable for use in children under the age of 12 years, unless under medical supervision.

WARNINGS AND SPECIAL PRECAUTIONS

If you suffer from any serious ailments or conditions; or if you are taking any prescribed medication, please check with your healthcare provider before taking this medicine.

- No studies on the effect on the ability to drive and use machines have been performed.
Please exercise care when driving or operating machinery until you know how it affects you.
It is unlikely to cause drowsiness.
- Porphyria: Safety has not been established.

Nutritional supplementation should not replace a balanced diet. Do not exceed the recommended dose without consulting a healthcare provider.

This medicine can affect the absorption of certain medicines like certain antibiotics, bisphosphonates, synthetic thyroid hormones, etc. Consult your healthcare provider for more information.

DOSAGE AND DIRECTIONS FOR USE

Adults: Take one tablet a day, or as directed by your healthcare provider.

SIDE EFFECTS

Side effects can include nausea, vomiting and diarrhoea. Not all side effects reported for this medicine are included in this leaflet. Should your general health worsen or if you experience any untoward effects while taking this medicine, discontinue use immediately and consult your doctor, pharmacist or other healthcare provider for advice.

KNOWN SYMPTOMS OF OVERDOSAGE AND PARTICULARS OF ITS TREATMENT

In case of an overdose, or if an overdose is suspected, contact your healthcare provider immediately. Treatment is symptomatic and supportive.

SAMESTELLING

FARMAKOLOGIESE KLASSIFIKASIE

D 34.12: Multibestanddeel formule.

Komplementêre medisyne: Gesondheidsaanvulling.

INDIKASIES

Kalsium is 'n mineraal wat bekend is vir sy sleutelrol in beengesondheid. Wellvita® Calcium Complex verskaf daagliks kalsium wat noodsaklik is vir die instandhouding van sterk bene. Dit is spesifiek geformuleer met magnesium en vitamien D3 om te help met kalsium absorpsie.

KONTRA-INDIKASIES

Vermy as jy hipersensitief (allergies) is vir enige van die bestanddele in die formule. Dit is nie geskik vir kinders onder die ouderdom van 12 jaar nie, behalwe onder die toesig van 'n geneesheer.

WAARSKUWINGS EN SPESIALE VOORSORGMAATREËLS

As jy enige voorgeskrewe medikasie gebruik of aan enige ernstige siektes of toestande ly, raadpleeg jou geneesheer voordat jy hierdie medisyne begin gebruik.

- Geen studies is gedoen om die effek wat die medisyne het op bestuur en die gebruik van masjinerie vas te stel nie. Wees asseblief versigtig wanneer jy bestuur of masjinerie gebruik totdat jy weet hoe die medisyne jou beïnvloed. Dis onwaarskynlik dat dit lomerigheid gaan veroorsaak.
- Porfirie: Veiligheid is nie vasgestel nie.

Indien jy ander medisyne (soos digoksiën en kalsium kanaal blokkers) gereeld gebruik, insluitend aanvullende (komplementêre) of tradisionele medisyne, of as jy enige addisionele medisyne begin neem terwyl jy hierdie medisyne gebruik, raadpleeg jou geneesheer vir raad. Hierdie medisyne kan die absorpsie van ander medikasie beïnvloed soos sekere antibiotika, bisfosfonate, sintetiese tiroïed hormone, ens. Raadpleeg jou geneesheer vir meer inligting.

DOSIS EN GEBRUIKSAANWYSINGS

Volwassenes: Neem een tablet per dag, of soos jou geneesheer voorskryf.

NEWE-EFFEKTE

Newe-effekte kan naarheid, braking en diarree insluit. Nie alle newe-effekte is ingesluit in hierdie voubiljet nie. Indien jy enige onaangename newe-effekte ervaar of voel dat jou algemene gesondheid verswak, hou onmiddellik op om die medisyne te gebruik en kontak jou geneesheer.
