WELLVITA CRANBERRY (tablet)

## COMPOSITION

Each tablet contains: Active ingredient: Cranberry powder extract 4:1 (*Vaccinium macrocarpon*) 800 mg.

## PHARMACOLOGICAL CLASSIFICATION

D 33.6 Western herbal medicine.  
Complementary medicine - Western herbal.

## INDICATIONS

This product is used for prevention of bladder and kidney ailments. This is based on traditional use only.

## CONTRA-INDICATIONS

Do not use this medicine if you are hypersensitive (allergic) to any of the ingredients in the formulation or aspirin. Not suitable for children younger than 12 years, unless under medical supervision.

## WARNINGS AND SPECIAL PRECAUTIONS

If you suffer from any serious ailments or conditions (such as atrophic gastritis); or if you are taking any prescribed medication (including blood thinning medication), please check with your healthcare provider before taking this medicine.

- This medicine might slow blood clotting and should be used cautiously with any other blood thinning medication. Discontinue use two weeks prior to any scheduled surgery.
- Cranberries might increase the risk of kidney stones if taken for long periods.
- No studies on the effect on the ability to drive and use machines have been performed. Please exercise care when driving or operating machinery until you know how it affects you. It is unlikely to cause drowsiness.
- Porphyria: Safety has not been established.

Nutritional supplementation should not replace a balanced diet. Do not exceed the recommended dose without consulting a healthcare provider.

## PREGNANCY AND LACTATION

If you are pregnant or breastfeeding, do not use this medicine. Consult your healthcare provider for more information.

## INTERACTIONS

If you are taking other medicines regularly, including complementary or traditional medicines, or start taking any additional medicines while taking this medicine, consult your healthcare provider for advice. Cranberries contain significant amounts of salicylic acid which is similar to aspirin and may have antiplatelet effects. If you are taking herbs and supplements that may increase the risk of bleeding (such as *Ginkgo biloba* and garlic), anticoagulant or antiplatelet medication (such as aspirin, warfarin, heparin or clopidogrel) and/or non-steroidal anti-inflammatory medications (such as ibuprofen or naproxen), please check with your healthcare provider before taking this medicine.

## DOSAGE AND DIRECTIONS FOR USE

Adult: Take one tablet daily with a meal and plenty of water, or as directed by your healthcare provider.

## SIDE EFFECTS

Side effects may include mild stomach upset and diarrhoea. Not all side effects reported for this medicine are included in this leaflet. Should your general health worsen or if you experience any untoward effects while taking this medicine, discontinue use immediately and consult your doctor, pharmacist or other healthcare provider for advice.

## KNOWN SYMPTOMS OF OVERDOSAGE AND PARTICULARS OF ITS TREATMENT

In case of an overdose, or if an overdose is suspected, contact your healthcare provider immediately. Treatment is symptomatic and supportive.

## STORAGE INSTRUCTIONS

Store all medicines out of reach of children. Store in a cool dry place below 25 °C and keep away from direct sunlight. Keep the container tightly closed.

## **INDIKASIES**

Hierdie produk word gebruik om nier en blaas kwale te voorkom. Hierdie is slegs gebaseer op tradisionele gebruik.

## **KONTRA-INDIKASIES**

Verm y as jy hipersensitief (allergies) is vir enige van die bestanddele in die formule of aspirien. Dit is nie geskik vir kinders jonger as 12 jaar nie, behalwe onder die toesig van 'n geneesheer.

## **WAARSKUWINGS EN SPESIALE VOORSORGMATREËLS**

As jy enige voorgeskrewe medikasie (insluitend bloedverduunningsmedikasie) gebruik of aan enige ernstige siektes of toestande (soos atrofiese gastritis) ly, raadpleeg jou geneesheer voordat jy hierdie medisyne begin gebruik.

- Hierdie medisyne kan moontlik bloedstolling vertraag en moet met sorg gebruik word in pasiënte wat enige ander bloedverduunningsmedikasie gebruik. Staak gebruik ten minste twee weke voor enige beplande sjirurgie.
- Bosbessie kan moontlik die risiko van niersteenvorming verhoog indien dit vir 'n lang tydperk gebruik word.
- Geen studies is gedoen om die effek wat die medisyne het op bestuur en die gebruik van masjinerie vas te stel nie. Wees asseblief versigtig wanneer jy bestuur of masjinerie gebruik totdat jy weet hoe die medisyne jou beïnvloed. Dis onwaarskynlik dat dit lomerigheid gaan veroorsaak.
- Porfirie: Veiligheid is nie vasgestel nie.

Indien jy kruie of aanvullings gebruik wat die risiko van bloeding verhoog (soos *Ginkgo biloba* of knoffel), stollingsteenmiddels of bloedverduunningsmedikasie (soos aspirien, warfarien, heparien of klopidogrel) of nie-steroidale anti-inflammatoriese medikasie (soos ibuprofen of naproksen), raadpleeg eers 'n geneesheer voordat jy die medikasie gebruik.
