Each tablet contains: Active ingredient: Vitamin C (ascorbic acid) 1 000 mg.

Other ingredients: Silicon dioxide, magnesium stearate, microcrystalline cellulose and coating.

INDICATIONS

Wellvita Vegan C-1000 is formulated without any animal derived ingredients to support special dietary choices. Vitamin C helps collagen formation for the normal function of gums, teeth, skin and cartilage as well as maintaining normal immune system function. Suitable for vegans & vegetarians.

CONTRA-INDICATIONS

Do not use this medicine if you are hypersensitive (allergic) to any of the ingredients in the formulation. Not suitable for children younger than 9 years, unless under medical supervision.

WARNINGS AND SPECIAL PRECAUTIONS

If you suffer from any serious ailments (such as kidney stones) or conditions (such as blood-iron disorders or sickle cell disease); or if you are taking any prescribed medication (including warfarin), please check with your healthcare provider before taking this medicine.

- No studies on the effect on the ability to drive and use machines have been performed. Do not drive or operate machinery until you know how it affects you.
- Porphyria: Safety has not been established.

Nutritional supplementation should not replace a balanced diet. Do not exceed the recommended dose without consulting a healthcare provider.

PREGNANCY AND LACTATION

INTERACTIONS

If you are taking other medicines regularly, including complementary or traditional medicines, or start taking any additional medicines while taking this medicine, consult your healthcare provider for advice. Vitamin C might affect the metabolism of certain medicines. These can include, but are not limited to protease inhibitors, estrogen, fluphenazine, warfarin and statins. Consult your healthcare provider for more information.

DOSAGE AND DIRECTIONS FOR USE

Adults: Take one tablet daily with a meal and plenty of water, or as directed by your healthcare provider.

SIDE EFFECTS

Side effect may include heartburn, nausea, diarrhoea, headache or stomach cramps. Not all side effects reported for this medicine are included in this leaflet. Should your general health worsen or if you experience any untoward effects while taking this medicine, discontinue use immediately and consult your doctor, pharmacist or other healthcare provider for advice.

KNOWN SYMPTOMS OF OVERDOSAGE AND PARTICULARS OF ITS TREATMENT

Symptoms of overdose include diarrhoea, nausea, vomiting and abdominal cramps. In case of an overdose or if an overdose is suspected, contact your healthcare provider immediately. Treatment is symptomatic and supportive.

STORAGE INSTRUCTIONS

Komplementêre medisyne - Gesondheidsaanvulling

INDIKASIES

Wellvita Vegan C-1000 is geformuleer sonder enige bestanddele van dierlike oorsprong om spesiale dieetkeuses te ondersteun. Vitamien C help met kollageenvorming vir die normale funksionering van tandvleis, tande, vel en kraakbeen asook om normale immuunstelsel funksie te ondersteun. Geskik vir veganiste en vegetariërs.

KONTRA-INDIKASIES

Verm y as jy hipersensitief (allergies) is vir enige van die bestanddele in die formule. Nie geskik vir kinders jonger as 9 jaar nie, behalwe onder die toesig van 'n geneesheer.

WAARSKUWINGS EN SPESIALE VOORSORGMATREËLS

As jy enige voorgeskrewe medikasie (insluitend warfarien) gebruik of aan enige ernstige siektes (soos bloed-yster versteurings of sekelsel siekte) of toestande (soos bv. nierstene) ly, raadpleeg jou geneesheer voordat jy hierdie medisyne begin gebruik.

- Geen studies is gedoen om die effek wat die medisyne het op bestuur en die gebruik van masjinerie vas te stel nie. Moenie bestuur of masjinerie gebruik totdat jy weet hoe die medisyne jou beïnvloed nie.
- Porfirie: Veiligheid is nie vasgestel nie.

As jy ander medisyne gereeld gebruik, insluitend aanvullende (komplementêre) of tradisionele medisyne, of as jy enige adisionele medisyne begin neem terwyl jy hierdie medisyne gebruik, raadpleeg jou geneesheer vir raad. Vitamien C kan moontlik veroorsaak dat sekere medisyne vinniger of stadiger gemetaboliseer word. Hierdie medikasie kan, onder andere, insluit: Protease inhibeerdere, estrogeen, fluphenasien, warfarien, statins, ens. Raadpleeg jou geneesheer vir meer inligting.

DOSIS EN GEBRUIKSAANWYSINGS

Volwassenes: Neem een tablet daaglik met 'n ete en genoegsame water, of soos jou geneesheer voorskryf.

NEWE-EFFEKTE

Newe-effekte kan sooibrand, naarheid, diaree, hoofpyn of maag krampe insluit. Sommige aangemelde newe-effekte is nie in hierdie voubiljet ingesluit nie. Indien jy enige onaangename newe-effekte ervaar of voel dat jou algemene gesondheid verswak, hou onmiddellik op om die medisyne te gebruik en kontak jou geneesheer.

BEKENDE SIMPTOME VAN OORDOSERING EN BESONDERHEDE VAN DIE BEHANDELING

Simptome van oordosering kan diaree, naarheid, braking en maag krampe insluit. In geval van oordosering, of indien oordosering vermoed word, kontak jou geneesheer onmiddellik. Behandeling is simptomaties en ondersteunend.
