COMPOSITION

Each capsule contains: Active ingredient: Vitamin C (ascorbic acid) 1 000 mg.
Capsules contain no sugar and are made from bovine gelatin.

Complementary medicine - Health supplement

INDICATIONS

Wellvita Vitamin C is an essential element to maintaining good health. It contributes to collagen formation for the normal function of gums, teeth, skin and cartilage while also maintaining normal immune system function during and after intense physical stress.

CONTRA-INDICATIONS

Do not use this medicine if you are hypersensitive (allergic) to any of the ingredients in the formulation. Not suitable for children younger than 12 years, unless under medical supervision.

WARNINGS AND SPECIAL PRECAUTIONS

If you suffer from any serious ailments (such as kidney stones) or conditions (such as blood-iron disorders or sickle cell disease); or if you are taking any prescribed medication (including warfarin), please check with your healthcare provider before taking this medicine.

- No studies on the effect on the ability to drive and use machines have been performed.
Please exercise care when driving or operating machinery until you know how it affects you.
It is unlikely to cause drowsiness.
- Porphyria: Safety has not been established.

Nutritional supplementation should not replace a balanced diet. Do not exceed the recommended dose without consulting a healthcare provider.

Vitamin C might affect the metabolism of certain medicines. These can include, but are not limited to protease inhibitors, estrogen, fluphenazine, warfarin and statins. DOSAGE AND DIRECTIONS FOR USE

Adults: Take one capsule daily with a meal and plenty of water, or as directed by your healthcare provider.

SIDE EFFECTS

Side effect may include heartburn, nausea, diarrhoea, headache or stomach cramps. Not all side effects reported for this medicine are included in this leaflet. Should your general health worsen or if you experience any untoward effects while taking this medicine, discontinue use immediately and consult your doctor, pharmacist or other healthcare provider for advice.

KNOWN SYMPTOMS OF OVERDOSAGE AND PARTICULARS OF ITS TREATMENT

Symptoms of overdose can include nausea, diarrhoea and stomach cramps. In case of an overdose or suspected overdose, contact your healthcare provider immediately. Treatment is symptomatic and supportive.

Komplementêre medisyne - Gesondheidsaanvulling

INDIKASIES

Wellvita Vitamin C is 'n essensiële element om goede gesondheid te handhaaf. Dit dra by tot kollageenvorming vir die gesonde funksie van tandvleis, tanden, vel en kraakbeen, asook om gedurende en na tydperke van fisiese inspanning, normale immuunstelsel funksie te onderhou.

KONTRA-INDIKASIES

Vermy as jy hypersensitief (allergies) is vir enige van die bestanddele in die formule. Dit is nie gesik vir kinders jonger as 12 jaar nie, behalwe onder die toesig van 'n geneesheer.

WAARSKUWINGS EN SPESIALE VOORSORGMAATREËLS

As jy enige voorgeskrewe medikasie (insluitend warfarien) gebruik of aan enige ernstige siektes (soos bv. bloed-yster versteurings of sekelsel siekte) of toestande (soos bv. nierstene) ly, raadpleeg jou geneesheer voordat jy hierdie medisyne begin gebruik.

- Geen studies is gedoen om die effek wat die medisyne het op bestuur en die gebruik van masjinerie vas te stel nie. Wees asseblief versigtig wanneer jy bestuur of masjinerie gebruik totdat jy weet hoe die medisyne jou beïnvloed. Dit is onwaarskynlik dat dit lomerigheid kan veroorsaak.
- Porfirie: Veiligheid is nie vasgestel nie.

As jy ander medisyne gereeld gebruik, insluitend aanvullende (komplementêre) of tradisionele medisyne, of as jy enige addisionele medisyne begin neem terwyl jy hierdie medisyne gebruik, raadpleeg jou geneesheer vir raad. Vitamien C kan moontlik veroorsaak dat sekere medisyne vinniger of stadier gemetaboliseer word. Hierdie medikasie kan, onder andere, insluit: Protease inhibeerders, estrogeen, fluphenasien, warfarien, statins, ens. Raadpleeg jou geneesheer vir meer inligting.

DOSIS EN GEBRUIKSAANWYSINGS

Volwassenes: Neem een kapsule daagliks met 'n ete en genoegsame water, of soos jou geneesheer voorskryf.

NEWE-EFFEKTE

Newe-effekte kan soobrand, naarheid, diarree, hoofpyn en maagkrampe insluit. Sommige aangemelde newe-effekte is nie in hierdie voubiljet ingesluit nie. Indien jy enige onaangename newe-effekte ervaar of voel dat jou algemene gesondheid verswak, hou onmiddellik op om die medisyne te gebruik en kontak jou geneesheer.

BEKENDE SIMPTOME VAN OORDOSERING EN BESONDERHEDE VAN DIE BEHANDELING
