

## **PRIVACY POLICY**

TLink Golf Inc. respects the privacy rights of our online visitors, app users, and subscribers and members of our web site [www.golftlink.com](http://www.golftlink.com) (the »Site») and is committed to protecting the personal information collected about you. To further this commitment, we have adopted this Privacy Policy ("Privacy Policy") to guide how we collect, store, and use the information you provide us. By visiting our Site, you are accepting the practices described in this Privacy Policy and our Terms of Use. For our information collection and use practices with respect to children under 13, please see our special children's section below.

### **I. SCOPE OF THIS PRIVACY POLICY**

This Privacy Policy applies only to information submitted and collected online through the Site, and does not apply to information that may be collected by TLink Golf offline. By using and submitting personal information, you signify your assent to this Privacy Policy. TLink Golf reserves the right, at any time and without notice, to add to, change, update or modify this Privacy Policy and our Terms of Use, simply by posting such change, update or modification on the Site. Any such change, update or modification will be effective immediately upon posting on the Site. Your continued use of any of our websites will signify your acceptance of these changes

### **II. INFORMATION COLLECTED**

#### Personal Information

To access certain services offered via the Site, TLink Golf may collect information about you, but only if you voluntarily provide it to us. The types of personal information collected in conjunction with the activities listed above will vary depending on the activity. The requested information may include: (i) your name, (ii) mailing address, (iii) telephone number, (iv) email address, and, for those purchasing products online, (v) credit card information. Parents or legal guardians providing parental consent (via our Parental Consent Form) may be asked to provide their child's name and email address in addition to information about themselves. You may choose not to provide certain information, but in doing so you may not be able to take advantage of many of our features.

#### Use of Cookies

TLink Golf may use cookies on its Site. A "cookie" is a small bit of record-keeping information that sites often store on a user's computer. Cookies do not include people's names, email addresses, or other information that is personally identifiable; they are typically used to quickly identify a user's computer and to "remember" things about the user's visit. You can disable cookies or set your browser to alert you when cookies are being sent to your computer, although this may affect your ability to shop online and login.

### **III. USE OF INFORMATION COLLECTED**

TLink Golf may use your Personal Information to send you information about our company or our features, products or services, or promotional material from some of our partners, or to contact you when necessary, unless the customer has disagreed that TLink Golf uses its data. TLink Golf also may use your Personal Information for editorial and feedback purposes, for marketing and promotional purposes, for a statistical analysis of users' behavior, for product development, for content improvement, and to customize content and layout of the Site. Names, postal and e-mail addresses and phone numbers collected may be added to our databases and used for future calls and mailings regarding site updates, new products and services, upcoming events and the status of orders placed online. TLink Golf does not sell or rent your Personal Information to third-parties for marketing purposes without your consent. TLink Golf may share your Personal Information you provide with TLink Golf subsidiaries and related companies. TLink Golf may share Personal Information with business partners that assist TLink Golf in providing you services. TLink Golf is committed to giving you the choice whether or not TLink Golf uses your information for marketing purposes or shares information with business partners.

### **IV. COLLECTION AND USE OF CHILDREN'S PERSONAL INFORMATION**

We, at TLink Golf, recognize a special obligation to protect personal information obtained from young children. Therefore, with respect to children residing in certain jurisdictions, no information should be submitted nor posted to the TLink Golf forum by children 13 years of age or under. In order for children 13 years old and under in such jurisdictions to participate in forum activities that require registration, we require prior written permission or other verifiable consent from a parent or guardian. In other jurisdictions, prior written permission or other verifiable consent may be required from a parent or guardian for children under 14 or 18 years of age. Upon registration, the appropriate permission form will be made available. This form must be signed by the child's parent or guardian and returned to TLink Golf by fax or mail to the Privacy Policy Administrator detailed in the Parental Consent Form instructions. Children 13 and under may not participate on certain portions of our sites. In some cases, we may not permit children under 14 or 18 years of age to participate in certain portions of our sites.

### **V. SAFEGUARDS**

TLink Golf maintains appropriate safeguards that ensure the security, integrity, and privacy of the personal information we collect and store about our account holders, including children under 13. Personal information collected by TLink Golf is stored

only accessible by authorized employees. In addition, our online store will on release use industry-standard encryption to prevent unauthorized electronic access to sensitive financial information such as your credit card number. We also have security measures in place to protect the loss, misuse, and alteration of the information under our control (i.e., maintain data quality). Before we allow web users to access their personal information, for example, we verify their identity by requesting that they submit information such as their username and password. We also take reasonable steps to ensure that third parties to whom we transfer personal information provide sufficient protection of such data.

You should be aware that the Site may from time to time contain links to third-party web sites. TLink Golf is not responsible for the privacy practices or the content of such web sites.
