We do not manufacture isopropyl alcohol; therefore, it is not considered a carcinogen in our products. D-limonene is flagged as an IARC 2B because it could be included as part of the generic hydrocarbon group. However, the IARC monograph specifically states that d-limonene has no carcinogenic effects. Therefore, it is not considered a carcinogen.
