100 unit vial of Botox \$601 (treats between 2-4 patients)

1mL syringe of Juvederm Ultra XC (typically treats 1 patient site bilaterally)

1mL syringe of Juvederm Ultra Plus XC (typically gets 1 patient site bilaterally)

Juvederm can be purchased must be purchased per box (2 syringes come in each box). can purchase one

Juvederm Ultra or Ultra Plus XC - \$350 for 1 and \$700 for the box of 2 because we include the canula which is a separate cost and it is worth it because it greatly decreases bruising.

Juvederm Vollure and Volbella are \$380(1) and \$760(box of 2)
