

# COBBA SHORTS

## Cobba Shorts 3 months Limited Warranty

Your new Cobba Shorts are covered by 3 months limited warranty (the “Shorts Warranty”). This limited shorts Warranty gives you specific legal rights, and you may also have other rights, which vary from state to state.

### A. Products covered by this limited shorts Warranty

This limited shorts Warranty extends to shorts manufactured by Cobba store, purchased directly from Cobba store, and located in Australia.

### B. Who this shorts Warranty extends to

This limited shorts Warranty extends to the original purchaser of any shorts who is located in Australia. All Cobba store warranties, including any implied warranties, are valid only for the period of time the shorts is owned by the original purchaser of the shorts. The “original purchaser,” for the purposes of this shorts Warranty, is the first purchaser of the shorts from Cobba store or a Cobba authorized retailer. Please retain a copy of your receipt as a proof of purchase. All Cobba store limited warranties are not transferable.

### C. Cobba store’s limited shorts Warranty and Responsibilities

Cobba store warrants the shorts in its original packaging sold to you against defects in material and workmanship set forth below (“Defects”) for a period of 3 months from the time your shorts are purchased by you, when the shorts are used normally for their intended purposes.

#### D. What this limited shorts Warranty covers

This limited shorts Warranty applies to Defects due to faulty workmanship or materials, subject to the limitations described in this warranty.

This limited shorts Warranty does not cover the following:

- Normal wear and tear as a result of washing and intended use.
- Comfort preference.
- Fit preference.
- Physical abuse or damage to the shorts, including but not limited to, burns, cuts, tears, sharp object damage, oil damage, or oil stains; provided, that the defect is caused by such abuse or damage.
- Any shorts (whether manufactured by Cobba store or not) sold by resellers.

In the event of a Defect, Cobba store's sole and exclusive liability and your sole remedy under this limited shorts Warranty will be, at Cobba store's option, to provide a replacement shorts, subject to your fulfilment of "Your Responsibilities" below.

#### E. Your responsibilities

In the event of a Defect and in order to get the benefit of this limited shorts Warranty, you must return your shorts to Cobba and provide Cobba with proof of the original date of purchase. Should shipping costs be required to return your sheets, you will be responsible for those costs. Evidence of a Defect along with genuine reasonings and any claims must be sent to the address set forth at the end of this limited shorts Warranty. In the event of a Defect, Cobba store will ship replacement shorts to you.

Replacement shorts are subject to the same limited shorts Warranty as the original shorts. If you obtain replacement shorts, the warranty term of the replaced shorts begins from the date of purchase of the original shorts.
