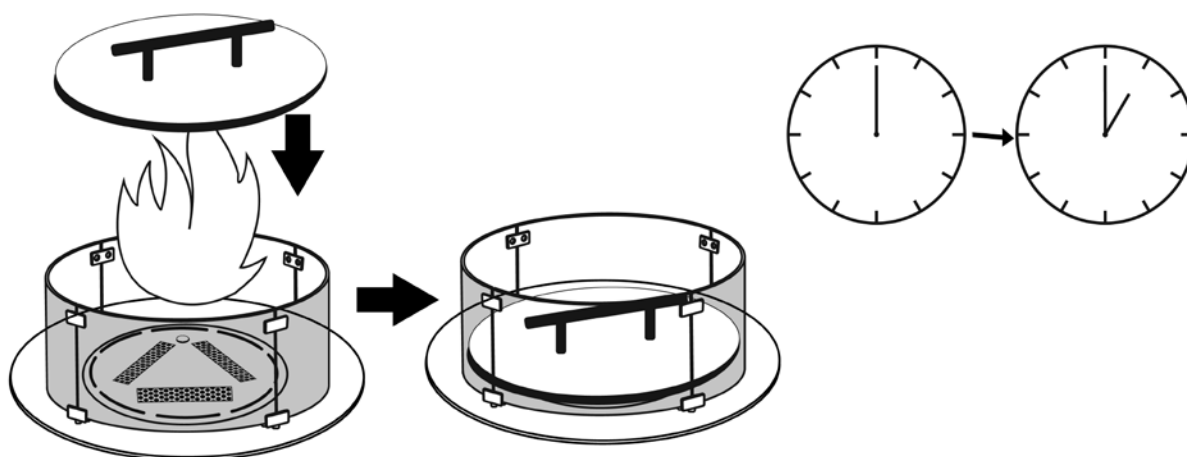
4 EXTINGUISHING THE BURNER

How to extinguish the burner

- a** Let the burner burn through all the fuel (see approx. burn times per the burner size on previous page).
- b** Using the supplied Burner Lid, approach the lit fire with caution and place it directly down over the flames. The lack of oxygen to the burner will extinguish the flames/fire. **DO NOT REMOVE THE LID.** The Burner Lid will be HOT

to the touch. Do not touch burner lid for at least 1 hour (60 minutes) after placing it on top of lit burner.

Note, there may appear to be smoke/steam after extinguishing the burner. This is simply the heat continuing to vaporize the fuel. This is not smoke, nor is it dangerous. It will subside in a few minutes. You may notice some moisture build up on the bottom of the lid. This can be wiped off with a paper towel AFTER 60 minutes of the burner cooling.

5 REFUELING THE BURNER

Level surface

- No placement of a fire pedestal or fire table within 24 inches / 61 CMS of any type of building or wall).
- ONLY operate the Burner in calm weather conditions.
- DO NOT EXPOSE BURNER TO RAIN.
- Always keep Children and Pets away from burning fire table or fire pedestals.
- NO strong winds or extreme weather.
- ENSURE ALL RECOMMENDED CLEARANCES ARE MET PRIOR TO LIGHTING THE BURNER.
- PROCEED WITH CAUTION in determining where to locate or place any fire pedestal. Make sure that the fire pedestal cannot be easily blown over by strong winds. Do not place / locate in active or busy walkways. Place in sheltered, safe locations away from heavy human or pet / animal traffic
- NO sitting ON or right next to fire table or fire pedestals that could result in hair igniting, or any other related loose object.
- These products are solely for use as decorative fire pedestals or fire tables. DO NOT sit on, jump on / off, climb on to, stand on, play on or use these products as a step ladder at any time. Standing on or using the item not as intended is highly dangerous and will damage the product material and surfaces.
- Tables are not for climbing on. Never climb on top of any fire table or fire pedestal – this is dangerous and can result in severe injury.
- NO fabrics next to or hanging over fire table or pedestals.
- No Hanging plants or low tree branches over fire.
- No Cooking with use of the burner. The burner and the fire are NOT for cooking – Fuel will taint the flavor of the food. For ambiance use ONLY. Food of any type could enter the reservoir through the vents and permanently damage the operation of your burner.
- No standing close to or leaning over the fire as this could result in igniting a fire on your person.
- No placing hands over the fire as this could result in burning oneself

Fire is always to be supervised by a responsible adult.

Fire is only to be operated by a responsible adult, defined as:

A physically capable adult (over 18 years of age) who is not intoxicated or on any type of recreational drugs.

An ABC Fire Extinguisher is ALWAYS to be located in close proximity (or same room) as fire table or fire pedestal.

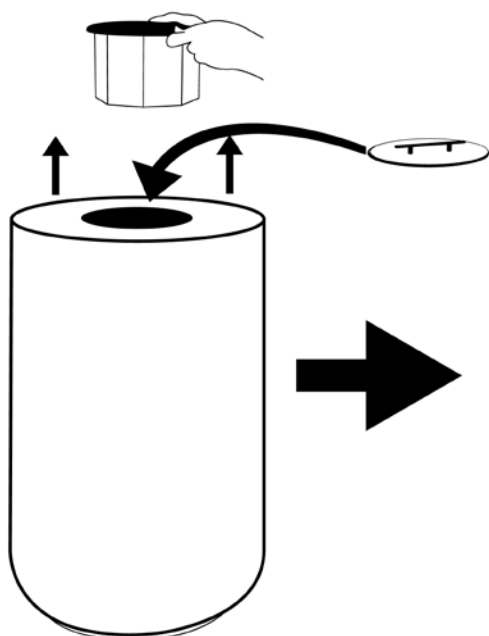
CARING | STORING YOUR PURCHASE

How to Care for your Super.Bio.Fuel Burner

- a** Remove burner when not in use.
- b** Store the empty burner in a safe, cool covered location (for example an outside shed or garage is ideal), away from easy access by children.



- c** Place fire burner lid over empty fire table burner hole.



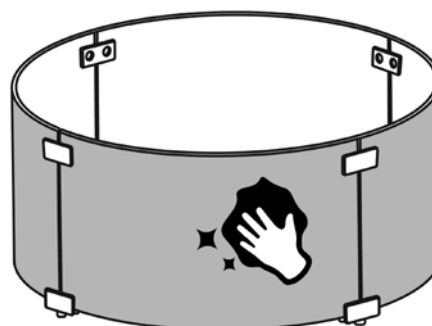
- d** Once a month (or when visibly scorched), empty fire burner and clean the exterior of the burner. We recommend you use: CARON & DOUCET - BBQ Cleaner Oil, (available on www.Amazon.com). This is a heavy-duty metal cleaner with the perfect combination of cleaning solution and abrasives to tackle the toughest stainless scorching and discoloration on stainless steel burners.

BENEFIT: One-step cleaner/polisher saves time.

SPECIAL INSTRUCTIONS: Just rub in the same direction of the grain of the stainless steel.

DO NOT USE OTHER ABRASIVES OR ANY ABRASIVE CLOTH (Steel wool, etc.)

Each Ingot item is coated in hand-hewn metal which is either dipped in other metals to provide a dazzling array of colors or finishes. Beneath the surface patina, is a sheet of metal.

Our Handmade Metal Collection includes a protective finish and Sealant. This clear coat sealant is just to protect the metal finish from weather **

In order to keep your Ingot merchandise looking good for years to come, we recommend the following:

Simple Product Care steps to take to protect your Ingot Collection Product:

- When not using the decorative accessory or furniture item, use a breathable ventilating furniture cover.
- Protect against heat damage marks: Such marks can become visible from placing hot pots or pans directly on the surface, **ALWAYS** use a hot pad coaster or placemats (with a soft underside) for anything that comes directly from the oven or stove to protect the metal and Sealant.
- Avoid the hot wax from candles; boiling water or any kind of hot liquids coming into contact with the Ingot merchandise item, this could damage the protective sealant/coating.
- * Never store any item directly on top of the surface, of any Ingot Product. Doing so could easily scratch, dent, puncture, or compromise the sealant that is applied to protect the finish.
