HipSaver, Inc warrants its products and its parts against defects in materials or workmanship for a period of one (1)-year commencing upon date of formal acceptance of the product(s) by the designated U.S. Government representative in accordance with the government's inspection and acceptance procedures contained in the cognizant contract.

HipSaver, Inc shall not be responsible for damage due to normal use, wear and tear, improper use, abnormal or abrasive washing conditions, any damage due to improper fit.

During the one (1)-year warranty period, HipSaver, Inc will replace defective products with new products, without cost to the U.S. Government.

Government ordering activities seeking product warranty application for products formally accepted by the U.S. Government shall contact HipSaver, Inc's customer service by telephone at (800) 358-4477 or by e-mail at cs@hipsaver.com for instructions for replacement. HipSaver, Inc Customer Service hours of operation is 9 AM – 5 PM, EST.

Products furnished to the government requiring warranty work will be subject to this amended Commercial Warranty and ordering activities shall notify HipSaver, Inc Customer Service, by telephone or e-mail, for warranty work. Products covered by the amended Commercial Warranty which require return to HipSaver, Inc will be returned in strict accordance with HipSaver, Inc's amended Return Goods Policy.

Return Goods Policy:

HipSaver, Inc. modifies and supplements its Commercial Return Goods Policy, contained herein, as follows for U.S. Government Contracts:

Non-Defective Products

A non-defective product may be returned to HipSaver, Inc within sixty (60) calendar days from date of the government's formal acceptance of the product(s) (see below for return of defective products).

Prior to returning a product(s) to HipSaver, Inc, the government customer must contact HipSaver, Inc's customer service by telephone at (800) 358-4477, or via e-mail at cs@hipsaver.com to obtain a Return Authorization (RA) Number. Product(s) returned by the government without an RA Number will not be accepted and will not be considered a valid return under HipSaver, Inc's Return Goods Policy and a refund will not be given.

Costs for shipping returned goods shall be borne by the government. Collect-on- Delivery (COD) shipments will be rejected and will be ineligible for a refund.

Return Goods Authorizations will not be given if Hipsaver, Inc's customer service is contacted by the government later than 60 calendar days after the date of government's formal acceptance of the product(s).

HipSaver, Inc will inspect each product returned under this return goods policy to ensure the product has not been tampered with or damaged in a manner so as to compromise HipSaver, Inc's ability to return the product to inventory or otherwise resell the product.

HipSaver, Inc will immediately notify the government ordering activity of any returned products received which are damaged, have been tampered with, or returned in a condition which makes it impossible to return the product to HipSaver, Inc's inventory for resale. HipSaver, Inc will determine the return product(s)' received condition and eligibility/fitness for return in conjunction with the government ordering activity

Disagreements between the government and HipSaver, Inc as to the condition/fitness of the returned product will be treated as a dispute under the contract, and resolved accordingly.

Products shipped in error by HipSaver, Inc, e.g., to the incorrect consignee, may be returned to and at HipSaver, Inc's expense. Consignee's in receipt of misdirected shipments must contact HipSaver, Inc's customer service at (800) 358-4477, or by e- mail at cs@hipsaver.com, to obtain a RA and instructions for shipping. HipSaver, Inc will make arrangements with a carrier for pick-up and shipping of the misdirected product(s).

Defective Products
