

## SCHOK LIMITED ONE YEAR LIMITED WARRANTY

All Schok products are designed and manufactured to offer the best quality standards and trouble-free operation. In the event that a device is not working correctly or is defective in workmanship or materials and you are the original purchaser, we will repair or replace it (at our option) free of charge from the original date of purchase, for up to 12 months.

Before sending your device to our service center, we strongly recommend that you perform a full backup of all your data (contact information, pictures, ringtones, or any other data you do not want to lose). In addition, if your device has a microSD card, please remove it, and store the card for installation when the device is returned. Schok is not responsible for and does not guarantee restoration of any third-party software, personal information, or memory data contained in, stored on, or integrated with any wireless device, whether under warranty or not.

Repairs made by Schok or its authorized Service Providers under this Limited Warranty ("Warranty Service") are covered for the balance of the original Warranty Period. This Limited Warranty covers only the purchase of new Products from Schok or an authorized reseller or authorized distributor of Schok Products. This Limited Warranty is personal to you and not transferable. No retailer or other third party is authorized to make any representations on behalf of Schok or to modify this Limited Warranty.

## WHAT IS NOT COVERED?
