

END USER LICENSE AGREEMENT

This agreement dictates the terms of use of the font software issued by 23in between you, the downloader/licensee, and the maker, 23in. By installing the font software you acknowledge to understand and promise to comply to the terms stated in this agreement.

1. PERMITTED USE

The purchase of this license grants non-transferable, limited and non-exclusive right to directly install solely on *the maximum number of computers entered in the purchase order receipt*. Copies may be made for archival purposes. This software is copyrighted and contains intellectual property information protected by law.

DISTRIBUTION

You are not authorized to reproduce, license, sublicense, sell, lend, lease or otherwise distribute the font software. Exceptions apply when supplying the font files to a commercial printer or other pre-press facility in the scope of a defined project, only in order to prepare for printing and print your documents.

CLIENT > DESIGNER

If you are a person or company that hires a design studio to create a project for you, you are not permitted to share the font software with the design studio except in non-embedded image formats*. Third party designers who need to make edits using the font software must purchase a separate license.

DESIGNER > CLIENT

If you want to send your client a file that permits the client to edit or modify the file using the font software, your client will need to purchase its own license.

2. CORPORATE OR OTHER LICENSING

3. MODIFICATION AND REDISTRIBUTION

The font software, its glyph shapes and underlying code may not be modified without permission from 23in. This includes extracting, decompiling, modifying, reformatting, translating, reverse-engineering, assembling, re-digitizing, or discovering the source code of the licensed software.

4. COPYRIGHT

The font software, its glyph shapes and underlying code remain exclusive intellectual property of 23in and are protected by copyright and intellectual property laws throughout the World.

5. DISCLAIMER

The font software is delivered "as is" without warranty of any kind. The maker of this font software is not liable for anydamage (physical, financial or other) resulting from the use of the font software as well as consequences resulting from the dealings with the font software.

6. UPDATES

23in agrees to provide licensees with free updates as the development of the font software progresses. 23in may discontinue work on font software at any time, for any reason. This agreement shall remain in effect regardless of the future plans for the font software.

7. EMBEDDING

Embedding of Open-Type font software designed for desktop installation into documents, applications or internet pages is currently prohibited. You may upload an image created with the font software to your website, but you cannot embed the font software in the website.

8. TERMINATION

This agreement and the attached permission of usage may be terminated — without notice — by 23in if you, the licensee, fail to comply the terms contained in this agreement. By request of the maker you have to delete all copies of the font software.
