

Terms of Service and Disclaimer

DISCLAIMER, ASSUMPTION OF RISK AND WAIVER

I warrant and acknowledge that I am the adult player named below and that I am authorized on behalf of myself, my heirs, assigns and next of kin, to hereby enter into the following agreements IN CONSIDERATION OF my being able to participate in any way at practices, games or other activities ("EVENTS") at the Randy Johnson Park Bluff Creek Fields in Playa Vista.

DISCLAIMER, ASSUMPTION OF RISK AND WAIVER: I acknowledge that participation in soccer necessarily involves travel, play in adverse field conditions, contact with considerable force, and risk of severe, permanent physical injury including bruises, scrapes, strained, sprained or torn muscles, tendons or ligaments, broken bones, dislocation of joints, concussion, brain damage, nerve and spinal cord injury, paralysis and death. I WILLINGLY AND VOLUNTARILY ASSUME ALL SUCH RISKS. I HEREBY RELEASE, DISCHARGE AND AGREE TO HOLD HARMLESS, to the fullest extent permitted by law, David Bina, PlayaKicks, Playa Vista Parks and Landscape Corporation, FirstService Residential California, LLC, and Playa Capital Company, LLC by Brookfield Playa Management, Inc. and any agents, employees, officers and directors of said persons or entities ("RELEASEES") from any and all claims, demands, costs, expenses and compensation arising out of or in any way related to an injury or other damage that may result to said participant or to members of my family or my household or individuals I invite or for whom I am otherwise responsible while participating in or present at any of the EVENTS, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. I acknowledge that the Releasees have not evaluated whether the field is in suitable condition for soccer play, and if I observe any concern in my readiness for participation in the EVENTS or with the condition of the field, I will remove myself from participation. I further acknowledge and accept that this Disclaimer, Assumption of Risk and Waiver is intended to be as broad and inclusive as permitted by the laws of the State of California and agree that if any portion of this Disclaimer, Assumption of Risk and Waiver is deemed to be invalid, the remainder will continue in full legal force and effect.

This Agreement shall be construed, governed, interpreted, and applied in accordance with the laws of the State of California without reference to any doctrine of conflict of laws.

BY CHECKING THE BOX WHEN I ORDER A TICKET, I AM AGREEING TO BE BOUND BY THIS AGREEMENT.

TERMS

These terms and conditions govern the play of amateur soccer at the Randy Johnson Park Bluff Creek Fields in Playa Vista at times reserved by PlayaKicks.

1. All players must agree to the waiver prior to participation.
2. All players must be 18 years or older.
3. No player may slide tackle or engage in rough play.
4. Players will be courteous to one another and will not engage in bad-mouthing or have a negative attitude.
5. Players must wear appropriate attire for playing soccer.
6. Players may be removed from participation by a PlayaKicks representative for any reason.

REFUND POLICY

Your payment to PlayaKicks for participation in amateur soccer play at the Randy Johnson Park Bluff Creek Fields in Playa Vista is non-refundable, regardless of whether for any reason the field becomes unavailable or a player is unable to play. However, PlayaKicks may refund any amount as it determines in its sole discretion.
