

Wurtzite P85 warranty

Lifetime Warranty Applicable Vehicles

Roadworthy Motor Vehicles excluding trucks and buses (less than 1 year old by manufacturing date and less than 1000 kms) with factory clear coated paint finish.

Wurtzite P85 warranty only applicable if installed by a Wurtzite Approved applicator/dealer.

5 Year Warranty Applicable Vehicles

Roadworthy Motor Vehicles excluding trucks and buses (less than 5 years old by manufacturing date) with factory clear coated paint finish.

Wurtzite P85 warranty only applicable if installed by a Wurtzite Approved applicator/dealer.

Type of Cover

Wurtzite warrant to the owner of the nominated vehicle's exterior painted surface coated with Wurtzite P85 under the following terms & conditions, limited to environmental fallout such as; bird droppings and bug splatter to the coating. Should this occur, and providing that all of the terms and conditions have been met, Wurtzite will rectify and reapply the coating under the "*Limit of Liability*".

Period of Cover

Wurtzite lifetime warranty requires an annual service inspection to uphold the warranty guarantee. Failure to complete an annual service will result in a 5 year warranty from the date of the last service. Once the 5 years have expired the warranty will be terminated.

General terms and conditions

The following general terms and conditions apply only to Wurtzite P85.

1. Lifetime warranty starts from the date of application for new vehicles less than 1 year old and less than 1000 km traveled.
2. Warranty cover is only valid if the Approved Applicator has issued a Wurtzite Manufacturers Warranty Card and has a Tax Receipt for proof of purchase.
3. This agreement excludes vehicles used for commercial purposes at any time previous to, presently, or during the course of this warranty period.
4. Any application, re-application, repair work or other work carried out on the coated surface must be applied, reapplied, or repaired by an authorized Wurtzite approved applicator/dealer after claim approval. Re-treatment to the repaired area is at the owner or insurers expense and is to be carried out within 45 days.
5. The Wurtzite approved applicator/dealer must be notified of any claim due to failure of product performance within 30 days of occurrence.
6. The vehicle exterior paint work must be maintained and washed regularly to Wurtzite recommendations to prevent contamination build up (ie, fortnightly/monthly).
7. Warranty is non-transferrable

Exclusions

Wurtzite or its approved applicators/dealers shall not accept liability for the following.

1. Warranty is valid for factory clear-coated systems only and excludes any non-clear-coated or matte finishes or respray.
2. Pre-existing damage or deterioration;
3. Damage caused by careless washing techniques not approved by wurtzite approved dealers i.e. swirl marks, scratches, marring, water spots, soap staining or etching.
4. Damage caused by manual or automatic wash brushes, contaminated and/or abrasive cloths and sponges.
5. Damage caused by collision, accidental damage, vandalism, malicious damage, fire,

hail, flood, stone chips, collision, surface rust, rail dust, physical damage, paint over spray.

6. Deterioration of factory paint work or repaint or any other treated part of substandard specification, materials or workmanship by vehicle manufacturers, their dealerships, third-party suppliers or modifiers, or professional detailers not authorized by Wurtzite.

7. Areas that have not been retreated within 30 days after a paint repair.

8. Any claim for matters which are covered by vehicle manufacturers' warranty;

9. Failed clear coat – peeling, hazing and fading.

Annual Service

1. Annual Services must be carried out by a Wurtzite approved applicator, within 30 days before or after the anniversary date of the last service to maintain the lifetime warranty.

2. Failure to undertake an annual service within the required period will change the period of cover to 5 Years from the date of the last service with annual service no longer required.

3. A fee determined by the Wurtzite approved applicator will be charged for the Annual Service which includes – Exterior Wash, Decontamination and Inspection.

Limit of Liability (Claims)

1. Any claim under this warranty must be made aware to an approved applicator within 30 days.

2. A Claim "Inspection Fee" of \$100.00 is payable, this is refunded if the warranty claim is approved for repair by Wurtzite .

3. Claim determination is at the sole discretion of Wurtzite, by retreatment by an approved applicator or refunding the application cost to the vehicle owner at a maximum

of \$1500 and terminating the warranty, whichever is less.

4. Any consequential loss including either incidental or indirect damages to arise from any claim under this warranty.

5. Any dispute arising under these terms and conditions shall be governed by the law of South Australia, the involved parties agree to submit to the jurisdiction of that State.
