## Session 10: Day 1

## The Christian Worldview of Law - Part 1



Read the following section before watching the first video of session 10.

n the majority of churches in America today, the doctrine of Grace is taught almost exclusively as the dominant characteristic of Christianity. The knowledge and the necessity of obeying the Law is downplayed and even ignored in many cases. And while it is absolutely true that we are saved by grace through faith and not by works, it is also fundamentally true that we are saved for good works – and all our good works are simply the results that proceed from our following and obeying the laws and commands of God. In other words, we are not saved by works; but once we are saved, we are now enabled to obey the law (which we could not do



on our own before our salvation came), and we now can develop a love for obeying His commands.

Remember that one of our key concepts is that laws are necessary for life, because laws create order. A second vital concept is that our God is a God of balance. If Grace is emphasized at the expense of obeying the Law, Christians can lose our balance, thinking that we can get away with disobeying the Law because of God's grace. This is a serious misunderstanding of doctrine that has gradually taken over the thinking of a majority of Christians without most of us noticing.

The "feel-good" message has displaced the call for holiness in the church. The result is that the Christian community today has become so compromised in its views of Biblical law that there is virtually no difference between the cultural viewpoints of Christians and their unbelieving friends (consider same-sex marriage, homosexuality, abortion, and economic entitlements, to name a few).

In the not-too-distant past, it was the reliable and just rule of law in the United States

that was one of the major traits which attracted so many responsible, enterprising immigrants to America. But today, the rule of law is increasingly ignored. From the chief political authorities down to the youngest students in school, there seems to be no enforcement of the most simple laws. Lawlessness in society attracts lawless individuals. Where there is no law, there is chaos.

As in other *Thinking Like a Christian* classes, our first goal is to define the fundamental views of Biblical law, and contrast them with the ideas of the opposing worldviews. We will also look at the history of law in America in order to understand how and where our system became compromised. Once we understand the cause of the cracks in the wall, we can then see clearly where the foundations need repair, both in our own homes and then in the society around us.

#### The Fundamental Principles of Law

What is right - according to God, because He alone determines what is right. He is the Lawgiver. It's His laws

that govern the universe and they were created to give life. But fair is a subjective term. It depends on

personal opinions and feelings. "Fair" to one might be unfair to another.

#### **Early American Law**

1. According to the video, what were the 2 main ideas pertaining to civil rights that came out of the combination of Biblical and Roman Law.

- <u>*E* quality</u> under the law
- $\mathcal{P}$  rocedural  $\mathcal{J}$  ustice : the right to a fair trial

2. The Pilgrims placed major emphasis upon educating themselves and the next generations. Why do you think that might have played an important part in the success of early America?

Because all their lives revolved around knowing the Bible and believing it held the keys to abundant life

and success. They based every foundational idea upon the principles and precepts taught in it.

Therefore, our style of government and the Constitution itself were built upon those

principles and precepts.

3. A core belief of the Founders was that the 10 Commandments are God's foundation for all man's laws. But in the early 1800s, Harvard began to discourage the belief of the inerrancy of Scripture. How would that effect the foundations of American law?

It would destroy the foundations. Rather than resting solidly and unchangingly upon

God's eternal laws as written in the Bible, they began doubting it. From then on,

changing and even rejecting His words and laws became fair game, allowing sinful men to make

things up on their own.

4. What two main positions did Blackstone hold regarding the Bible that greatly influenced the Founding Fathers?

• (1) that man's law must be based on God's law and

(2) that the Ten Commandments were the heart of all law.

5. How would you define evolutionary law?

Law that evolves (changes) as man "evolves". Law either follows what the current culture embraces (not based upon

Godly principles), or it is to be designed by judges or legislators to lead the society - to fashion or remake it - based

upon the schemes of men.

6. What is the fundamental difference between Biblical law and evolutionary law, and why is this important?

Biblical law is perfect, fixed, eternal, always right, always good, always just (is blind to race, color, gender, infuence,

etc.). Evolutionary law is never sure and certain, always changing, preferential, unreliable; and prone to be unjust,

corrupt, and harmful to society.

7. The Case Law method of judging laws says that judges should "*guide the evolution of the interpretation of the Constitution.*" What could go wrong by applying this idea, and why?

All it takes is a majority of the court to make an illogical, prejudiced, or ill-informed decision regarding law and the

entire nation can suffer consequences. The decisions of the Supreme Court on the issues of abortion, same-sex

marriage, and Obamacare are prime examples.

8. What are your thoughts regarding this statement by Oliver Wendell Holmes; Supreme Court Justice (1902-1932)?

"The justification of a law for us cannot be found in the fact that our fathers always have followed it. It must be found in some help which the law brings toward reaching a social end."

It reflects arrogance and foolishness to the highest degree. It disregards the lessons of history and

presumes that these judges are just smarter than God and all the men before

them.

Christian centers of learning dominated in America - and this led

to our prosperity



2. Look up the **History of Harvard University** at <u>*Wikipedia.org*</u>, and read through the section on Unitarians. Then, look up **Unitarianism**.

Harvard held the highest standard of Christian universities and led America in education until the Unitarians (a cult)

were allowed to take over in 1800. Unitarianism is known for rejecting the fundamental Christian doctrines of original

sin and biblical inerrancy. This marked the opening of the floodgates into America's universities for the spread of

many similar anti-biblical philosophies.

3. Look up Sir William Blackstone and Blackstone's Commentaries.

He was a deeply committed and brilliant Christian lawyer and judge who wrote commentaries on Law using the

Bible as the authority. All American lawyers were trained by his commentaries until the mid-1800's.

#### 4. Look up Christopher Columbus Langdell.

Became a converted Darwinist from Christianity and radically changed the philosophy of law at Harvard - which eventually influenced virtually all law schools in the nation and turned us from Biblical law as our foundation to man's judgments.

The President of the U.S., and ratified by the Senate

### The ACLU vs. Christianity

he American Civil Liberties Union (ACLU) is one of the most powerful legal organizations in America. The organization has over 1,000,000 members and an annual budget of over \$100 million. Current positions of the ACLU include: opposing the death penalty; supporting same-sex marriage and the right of LGBT people to adopt; supporting birth control and abortion rights; eliminating discrimination against women, minorities, and LGBT people; supporting the rights of prisoners and opposing torture; the separation of church and state; and opposing government preference for religion over non-religion, or for particular faiths over others. 1. What are your thoughts about the following beliefs of Roger Nash, the founder of the ACLU?

"I am for Socialism, disarmament and ultimately, for the abolishing of the State itself..."

Does this sound wise? Why or why not?

NO. Socialism steals money, property, and freedom from those who work hard, develop their own talents, build

businesses that employ others, etc., and redistribute that wealth to those who are lazy or well-connected

with the government. It ruins productivity and creativity. Disarmament of the citizenry sounds great if

you're part of the government that is armed, but leaves the average person defenseless. Abolishing the State means

anarchy. Chaos.

# *"I seek the social ownership of property, the abolition of the propertied class and sole control of those who produce wealth."*

Does this sound wise? Why or why not?

Social ownership means no one owns anything; but the elite social managers (gov't officials) control everything.

They own everything.

"Communism is the goal."

2. In your words, how does this differ from the system of government presented in the U.S. Constitution? (*For assistance look up: <u>https://theconstitutionpolik6.weebly.com/6-ba-sic-principles.html</u>)* 

It established six different principles for how everything was to be run. These principles are 1)Popular Sovereignty - that the people are free and are the overseers of the governors; 2) a Limited Government - the power must rest in the states, local gov'ts, and people; 3) Separation of Powers - dividing the gov't into 3 branches so that no arm has the power to control all; 4) Checks and Balances - tools for each branch to check the others for overreach; 5) Judicial Review - a separate branch for courts to judge if laws are constitutional or executives are exceeding their lawful power; and 6) Federalism - the distribution of powers between the central gov't and the states, where the states have the

greatest control.

3. What are your thoughts about the beliefs of Ruth Bader Ginsberg as stated in the video?

Personal responses (Example):

She has a debased (corrupt, perverted) mind - what Romans 1 predicts will happen to those who reject God.

How could someone who thinks like this ever become such a powerful individual?

#### What does this mean to us?

4. When judges, lawyers and legislators become corrupt in their thinking and veer away from righteous principles, how does it affect the common person?

We cannot escape the consequences of the bad laws and the judgment that will eventually fall upon the

nation that allows this to continue.

5. Should Christians be encouraged to get involved in the practice of law if they are inclined? Why?

Absolutely. Because without clear-thinking, logical, virtuous and biblically-grounded men and women

filling positions in the law profession, things will only get worse. The blind will lead us all into a ditch

- or worse.

supports. He believed that excellent education was of the highest priority, and that it must be grounded in the

moral principles of the Bible.

#### **Conclusion: The Christian View of Law**

"Lady Justice is Blind and Impartial."

4. What is the meaning of her blindfold?

Justice does not look at color of skin, race, gender, influence etc., to decide between right and wrong, guilt or innocence. It is impartial. Everyone is equal according to the law.

In what ways do we see this principle being ignored or violated today?

Laws are enacted that show preference to certain classes or identitie

over others.

5. What if Lady Justice is not impartial? What difference would that make in the justice system?

There would be no justice. Either the laws are applied to all equally or justice doesn't exist. The society will

eventually fall into lawlessness.

6. *Read Deuteronomy 16:18-20.* What does Scripture say happens when partiality is shown because a judge is bribed?

A bribe blinds the eyes of the wise and subverts the cause of the righteous. If allowed to continue, destruction of

the land will follow and the people will lose their land.

#### The Sword of Justice

7. *Read 1 Samuel 2:10.* What does god say will happen to those who oppose God's laws?

They'll be "broken to pieces" (destroyed/punished) by God.



8. *Read Romans 13: 3-4*. What is the first role of government according to this passage?

Protector and promoter of the good and the avenger/punisher of evil.

9. What have you learned in this study of Law that you think is important?

(Personal responses) Ex: Law is ever-present and we cannot - we must not - ignore its importance. Our faith is built

upon the balance of Grace (love) and Law (justice) and neither can be ignored or diminished without causing a loss of

hese are just a few of many quotes from America's Founding Fathers that speak clearly to the cost of freedom in a government "of, by, and for the people."

Freedom is not free. Prior to America, there was never a country in all of history where the rulers were made to be governed by the people of that country, and the result had been 5,000 years of tyranny, oppression, and slavery. Liberty in America was purchased and has been preserved at the cost of hundreds of thousands of the lives of everyday people who believed that freedom was worth living - and dying - for.



But in today's culture, these ideas have been erased from history. Our pulpits and universities - which were once the epicenters for teaching Biblical applications of scripture to all of life - rarely mention the words *"duty"* or *"responsibility"* in the context of our privileged role to protect and preserve the precious values this nation was founded upon.

It is the high calling of Christians to be Salt and Light in a dark and decaying world, to warn and to influence the world for good. When the truth is withheld or suppressed, the society suffers. Christians have in our hands the Word of Truth. It is meant to be applied everywhere.

There is not an arena of life that is not sacred to God.

They lose freedom and property. They will be led towards corription themselves.

Samuel's sons had become greedy and unjust. And the priests/shepherds were leading the people into corruption

Most denominations of churches no longer believe in the inerrancy of Scripture and promote ideas and lifestyles

6. American Founding Father Benjamin Rush stated: "... *Without virtue there can be no liberty, and liberty is the object and life of all republican governments.*" What does this have to do with politics in our nation today?

As we abandon righteous laws, as we reject God's truth, we dismiss the very principles that allow for a free

society. Once we do so, our freedoms will be stripped away bit-by-bit.

7. Based upon the last question, what do you think is the remedy for the corruption in a society?

Go back to the basics. the nation was built upon the foundation of the Bible. The only remedy is to return

to it or we'll have proven that we're not worthy of the freedom we once had.

6. Search out and read **"The 1st Amendment"** on the internet. In your words, what does the first line clearly say about laws regulating religion?

There shall be no laws established whereby the government would rule over churches. Government will not

interfere with the business of the church.

7. What does it say about "separating church and state"?

The church must stay out of the church's business but it never says that the church is not to be involved in

the government's business. The First Amendment is most explicit in saying that everyone is guaranteed

free speech. That includes pastors and all who are a part of the church.

8. What does this say about Christians being involved in government?

? We have every right and reason to be involved.

9. Read Romans 1:18. What do the haters of God want to do with the truth?

Suppress it. Smother it. Silence it from being spoken.

10. Read Romans 1:28; John 3:20. WHY do they do so and what is the result?

They don't want God – or God's moral laws - regulating their lives. They hate light, and love the dark

because they prefer to practice evil.

John Knox Witherspoon was a Scottish minister who emigrated to America in 1768, where he became the 6th president of Princeton University. He transformed this college that had been designed predominantly to train clergymen, into a school that would equip the leaders of a new Protestant country for the work of ministry in church as well as in all of life. Besides the many students he prepared for church ministry, he also was responsible for the training of 37 judges (three of whom became justices of the U.S. Supreme Court); 10 Cabinet officers; 12 members of the Continental Congress, 28 U.S. senators, and 49 United States congressmen.

1. How vital of a role in the forming of America's government do you think this one man played? Explain why.

There is no way to measure his contribution. He was devoted to God and His word. He was devoted to

education and to the service of mankind; and because of these priorities in his life, God used him

mightily.

2. What do you think is the main difference between Witherspoon's approach to education and that of the teachers at the typical university today and why does this matter?

His entire foundation for truth and wisdom was the Bible. If the Bible is truly the perfect, inerrant, Word of

the Creator God Himself, then his words are dependable, powerful and worthy of trusting in for wisdom in

all areas of life. Outside of those Words, man can only guess or attempt to create his own reality. and that

method has never proved to be successful

3. Dr. Benjamin Rush believed that if every individual owned a Bible, and studied and obeyed it, all our problems (including crime, slavery, etc.) would diminish. Do you agree, and what does this say about the importance of encouraging individual and group Bible studies?

Yes of course. It is vitally important for us to begin again to consider Bible study (and application) as a high

priority in our lives - especially today when our voices are being drowned-out because so few Christians are

well-equipped to know what we believe and why -

## **Christian Voting Facts**

- Total Evangelical Christians: 60 Million (2017)
- Only 36 million are registered (60%) are registered to vote, and of those, only 30%-50% actually vote (18-30 million)
- Average total voter turnout for a Presidential election is about 130 million.
- The average presidential election is decided by only 2-8 million votes difference.

### Conclusion: if only 10-15% more of evangelical Christians actually voted Biblical values, Christian voters would own nearly every issue and election.

here is no higher responsibility and no higher privilege for Christian parents than to raise our children up *"in the ways of the Lord"*. There is no greater need in the world today than for parents to take command of the moral and practical education of their children. The biblical directive to teach our children is not optional. WE are responsible to oversee their education.

This doesn't mean that each of us must possess the complete knowledge and ability to personally teach our children every subject; but there is no Biblical precept that encourages us to send our children off to strangers for twelve years of their lives for their entire

education. It is because the church (and the families who make up the church) surrendered the education process into the hands of the state over one hundred years ago that we are in the dire predicament we find our society in today.

But the good news is that we are still able – especially in America – to turn the tables on the radical declines we have seen in public morality and practical functionality.

The first place to start is by realizing that our children are unique creations made in the image of a loving God who has gifted each one in ways that will complement the purposes for which He has created them

(*Ephesians 2:10*). And they are capable of learning far more than we can imagine when not forced to learn at the same pace as only those of the same age, fall-in behind those who do not have the same moral code, or blindly follow the instructions of those who have no vested interest in their lives.

Our Father is true to His promises. If we follow His ways and obey His instructions to teach them to our children... as we talk about them when we sit at home and when we walk along the road, when we lie down and when we get up... He promises "that it may go well with you and with your children after you, and that you may prolong your days in the land which the Lord your God is giving you for all time." (*Deuteronomy 4:40*)

## The Fundamentals of a Biblical Education: Clearly Communicating the Words and Principles of the Bible.

*Read Genesis 2:16-17, 3:2-4.* 

- Who was Adam's teacher? <u>God the Father</u> Who was Eve's teacher? <u>Adam (the man)</u>
- What did Eve misunderstand? The specific command of God was : Do not eat of the fruit He didn't say could not touch it.

• How did this misunderstanding lead to her a bad decision?

When she touched the fruit and didn't die, she may have lost faith in the truth and reliability of God's Word.

(Although this does not excuse her action - "without faith it is impossible to please God". Heb. 11:6)

• Who is held responsible for the fall? *Read Romans 5:12, 14; 1 Corinthians 15:21.* 

Adam is.

• Why? Consider the possible consequences if 2 generals have equal authority to make command decisions over the same battle.

A house divided against itself will fall (Mk 3:25). Leadership is a matter of authority – not superiority.

Who has been affected by this lack of communication between Adam and Eve? (*1 Corinthians 15:12*)

All of humanity

How would you apply the lessons from above in your life?

I am responsible to God for my actions; thus, it is vital for me to know His commands in order to act (to live)

in a way which conforms to His laws for life.

## **Knowledge and Wisdom**

1. Who is God speaking to in Deuteronomy 4?

All the people - the individuals of the Israelites

2. Do you think these words apply to us in our day? Why is this important?

Absolutely. Especially because they are spoken to a people who have been separated by God to be His special

people and given a land where they could live free"under God" - not as slaves under kings, pharoahs, or tyrants.

These instructions explain why those who perished before them failed to reach the Promised Land.

3. What is the result if God's people do not *"teach the children"* from one generation to the next?

They'll not know God, and therefore not know what they believe. They'll have no foundation upon which to build their lives. It will be like starting all over again from scratch. History forgotten will be

history repeated.

*Read Matt 28:19-20* (The Great Commission). Notice that the first portion of Christ's command is *"make disciples"*. But what is a disciple? The Greek word is mathētēs, which

is defined in Strong's Concordance: to disciple, i.e. *helping someone to progressively learn the Word of God to become a matured, growing disciple* (literally, *"a learner"*, a true Christ-follower); to train (develop) in the truths of Scripture and the lifestyle required, i.e. *helping a believer learn to be a disciple of Christ in belief and practice.* (Emphasis ours)

4. In your own words, what is involved in making disciples?

(Personal responses) For example: Regular time spent between teacher and pupil.

One-on-one time is important. The teacher is to model the lessons to be

learned. The most important lesson in everything is learning how to

apply the knowledge without sacrificing integrity and character

in the process. The moral application of knowledge is key.

5. What are some key differences between public school discipleship and Biblical discipleship?

Overcrowded classrooms. One-size-fits-all curriculum. Lack of

one-on-one mentoring. Lack of biblical morals as the foundation.

Lack of absolute truth because God is not acknowledged and the

Bible is not revered.

6. What is the difference between knowledge and wisdom?

Knowledge is accumulation of ideas and facts (biblically, knowledge is the truth of God communicated to the mind of man). Wisdom is the morally-correct application of that knowledge.

A biblically-based Education is absolutely critical because the lies of the enemy are so widespread and ever-present around us that we must work nearly twice as hard, it seems, to overcome them.

And it is the parent's responsibility to oversee their children's education, with the church (the body of believers) assisting in the actual process as needed.

8. *Read Deuteronomy 4:25-28; Joshua 5:6*. What results are predicted if the nation and the family does not heed God's instruction to teach the youth in His ways?

You will soon utterly perish from the land that you are going over the Jordan to possess. You will not live long in it, but will be utterly destroyed. And the Lord will scatter you among the peoples, and you will be left few in number among the nations where the Lord will drive you.

Joshua records that the generation who first received those directions didn't obey, and perished in the desert.

• Why do you think God commanded Moses to write the laws on stone?

They wouldn't be forgotten. To be a sign that God's Laws are eternal, foundational, and immovable.

• Read Deuteronomy 4:5-10. What did Moses do with the written Word, and why?

He obeyed God's command to teach; he did so because he feared the consequences that would come to

the people if he didn't teach God's law.

• *Read Deuteronomy* 5:6,9. What did God warn and command?

Warning: Be careful to govern yourself according to God's Law. Obey them and live them.

Command: Teach the children.

• In what ways might we not be heeding these warnings today?

Studying and devotedly living by them is low on our (most Christian's) priority list, behind enjoying our material possessions and benefits of living in America. By a vast majority, Christians give their children over to the godless State to teach their children. Many families spend more time on the soccer, football, or baseball field than they do reading and studying God's word.

- 2. *Read Joshua* 8:34-35.
- What exactly is Joshua commanded to read to the nation?

Every word of scripture - the easy and the hard words

• Why was it so necessary to include both the blessings and the curses?

They go together. Because we are prone towards taking the easy path, we must be clearly warned of the consequences of disobedience

• Do you think this "balance" of teaching is necessary for us today? <u>YES</u> Why?

God commands us to do so (learn and teach both blessings and curses) - for our own good!

- 3. *Read Judges 2:10-12*. A new generation arises that are not taught.
- What changed?

The next generation arose who had not been taught the Laws, so they turned and provoked God's anger. The parents and the priests didn't do their job.

• What were the results (*Judges 2:14-15*)?

Judgment followed. God delivered them into hands of invaders. They became slaves and suffered.

- 4. Revival occurred in Israel under Nehemiah. Religion became relevant.
- *Read Nehemiah 8:1-3.* Whose idea was it to teach the people the Law?

#### The people's idea

- Who was present? \_\_\_\_\_\_ All who could hear and understand
- How would you apply this in your home?

The same way. Just because the children are young, they hear and understand far more than we think they do.

• *See Nehemiah* 8:7-8. Describe what took place.

The priests and elders went among the people, helping them understand the meaning of the scriptures.

• Verse 8 states that the priests *"gave the sense*" of the words and commands they read. What do you think that means and how important is this principle?

They helped the people understand the words and principles in everyday language, using everyday examples,

illustrations, to make the teachings relevant to their lives.

5. *Read Jeremiah 6:13-14*. God criticizes the Priests and leaders for saying "*peace, peace*" where there is no peace. Why is it vital that we here both sides of a story – the positives and the negatives, the promises AND the warnings?

If they only present the rosy side, it gives an incomplete picture. The fear of the Lord is the beginning of

both knowledge and wisdom. Sometimes the motivation to not suffer the pain is stronger than the

expectation of blessings. Both need to be given.

## **Reality Check - The Dangers of Withholding the Truth**

The best education teaches application of Truth in the real world. But if the truth is suppressed or ignored in any environment, the outcome will be the same: the student and the society will suffer due to ignorance.

1. *Read Jeremiah* 6:14-15. What was the result in Old Testament Israel when the priests withheld warnings of judgment from God for their disobedience?

They disobeyed God's word and committed abominations, so God caused them to fall and be overcome

2. *Read 2 Timothy 4:2-4*. What is the warning Paul gives Timothy (and by extension, all pastor-teachers)?

Reprove, rebuke, and exhort, with complete patience and teaching. For the time is coming when people will

not endure sound teaching, but having itching ears they will accumulate for themselves teachers to suit their

own passions, 4 and (E)will turn away from listening to the truth and (F)wander off into myths.

3. How does this relate directly to the command that Christians are to be Salt and Light *(Matthew 5:13-16)* and Watchmen on the wall *(Ezekiel 3:17-19)*?

As we teach others (or read for ourselves) the Bible, we're not to neglect to speak the truth to those around us - even if it may sound harsh. A large part of our purpose is to not only share the Good News, but also to warn others and awaken them to the seriousness of the Message.

## The Value of Teaching the Truth

4. From 100 A.D. to 500 A.D., the church led in teaching the people. According to the video, what influence did this have upon the Roman Empire and upon the average person?

Christians took places of leadership in the Roman world - virtually filling them all. This gradually - but

powerfully - changed the world because Roman roads connected all the countries and cities in the Roman

Empire together. The vile and viscous gladiator games ended. Christian schools and universities were

formed.

5. From 500 A.D. to 1500 A.D. the Bible was not allowed to be translated into the common languages. Truth was withheld, and the people suffered. What event sparked a revival of the knowledge of the Bible?

The invention of Gutenberg's printing press

6. What difference did this make in the education of the common person?

For the first time ever, anyone could purchase his own Bible, which encouraged the common people to learn to

read and soon they became better educated than their Lords. And with an unquenchable hunger and thirst to know

the Word of God, they became immersed in the truth and changing the culture.

1. *Read Matthew 5:13-20.* Some properties of Salt: It dissolves easily in water; it is a preservative; it is a seasoning - it brings out flavors in bland foods; it kills bacteria – bringing healing. How might you apply these characteristics in your life?

• Dissolving: <u>by dying to pride. Becoming a</u>

servant. Considering others more important than myself

• Preserving: <u>By speaking the truth and warning</u>

others we can literally save lives



- Killing bacteria and bringing healing: <u>The truth sets us free from bondage, harmful lifestyles, bad</u> ideas and bad decisions

2. *Read Hosea 4:1- 6.* Just before the nation is taken into captivity Hosea gives this message.

• What was missing in the land?

Truth, mercy, and the knowledge of God

• What were the consequences to the nation?

Draught, famine, death, the people stumble and fall.

• What were the consequences to the children?

God "forgets them" - His hand of blessing is taken away

• What does this say to us today?

There are serious consequences for rejecting, neglecting, or ignoring God

### The example of Jesus

He taught them - through His words and example

• *Read John 12:49.* What was Christ's source for all His teaching?

The words of the Father

• What is the principle that applies to us?

We are to do the same. Not trust in our or another man's wisdom, but in God's.

• Read Matthew 28:19-20. What was Christ's command to us?

Go -- into our families, workplaces, communities, and throughout the world, and make disciples (learners) of all, teaching obedience to His Word.

• *Read John 18:37.* What is the relationship between the Great Commission mentioned above and the Truth?

When we teach or make disciples, our tool is the Truth of God. The Bible is all truth. Jesus is the Truth. Every

principle or precept in Scripture is truth. We aren't limited to quoting Scripture alone. Anytime we speak a

truth that is supportable by Scripture, we are giving a portion of the Gospel.

## The Value and Necessity of Communicating the Truth in Writing

4. The Bible has more original written evidence of its doctrines and beliefs than all other religions combined. What difference does this make?

It makes it more credible and more clearly defined than any others

5. *Read 1 Thessalonians 5:27, Colossians 4:16, 1 Corinthians 1.* What is Paul commanding here, and why?

For His letters to be passed around to the other churches so that they would be read and multiplied

### The Value and Necessity of a Well-rounded Education

5. Martin Luther believed that people need to be well educated. *"This is absolutely essential because people need to understand both the word of Scripture and the nature of the world in which the Word would take root."* 

• What do you think he meant?

Because the Word is Truth, it is need in every area of life and will bring light

• Give some examples of cultural changes we might expect from the Word of God taking root in society?

Heathy marriages, families, and communities. Greater peace. Greater prosperity. Greater unity.

- Explain what you think the results might be if a Christian does not learn how to apply the Word in everyday life?
- Hypocrisy will be the fruit of that person's life. This will lead to divisiveness with those who are

diligently trying to live by the words of God. The world will be disillusioned about the true Gospel.

1. The most powerful idea of the Reformation can be simply stated in 2 words: *Sola Scriptura (Scripture only)*. What does this mean and what effect did this idea have on the common person?

"Scripture alone": States that all truth is determined and verified by the words of the Bible. It is the source of ALL

knowledge and wisdom, and is our guidebook for a virtuous and prosperous life. This gives the common person an

inside track to receive direction and guidance from the omniscient Creator of all Himself. There could be no greater

source for success in all the world.

2. The Bible was translated and made available to the common man for the first time in history. How did this change the level of education for the average peasant?

It inspired the common folk to learn to read. Whereas they had always been taught and told that their purpose and value was mainly in supporting their lords - hopefully having enough themselves to get by and provide for their families. Now they became hopeful of rising above their slavery and poverty, and education by the Bible was the tool that eventually delivered them to freedom.



3. Read the following article: <u>https://tifwe.org/how-the-reformation-changed-educa-tion-forever/</u> What part did the churches play in the education of the people? The reformers believed that the primary responsibility of educating children fell upon the church and parents (with possible infrastructure support from the state). Luther personally started numerous schools in existing churches. Congregations were expected to provide the necessary funding and oversight. Parents were also expected to play an important role, not only making sure their children attended class but also reinforcing instruction at home. Church leaders would shepherd the instruction process and assess a student's progress by meeting with students and parents during the school year.

4. According to the video, what has been the main difference between the education of North Americans and South Americans?

The Bible and Bible reading was promoted in every way in North America because of the Protestant influence,

while it was banned or otherwise discouraged in South America until the 20th century

5. Why do you think it is so harmful to a society if the Bible is suppressed?

It silences truth. It shuts down freedom of speech, personal property rights, and discourages virtue. Conversely, it promotes illiteracy, lawlessness, and evil.

### Education Gone South - The Difference a Biblical Education Will Make in Nations

Within 16 years of the Pilgrim's landing, they established Harvard University; and the next 96 of the first 98 universities in America were founded by Christian denominations.

1. Name a few results of this educational policy in early America over the first 200 years (*Consider the developments that came from America as mentioned in Session 1 – the* "5,000 Year Leap.")

The prevailing worldview became deeply Christian – with

virtue as the highest character trait promoted to all. Christian morality

was diffused in all vocations and God's blessings flooded the American culture, blessing the world.

2. South America – founded mainly by Roman Catholic states – did not promote education for all, and the Bible was outlawed for the common people well into the 20th century. What difference do you see between the U.S. and most South American countries? Look up: <u>http://www.wayoflife.org/database/persecutionofbible.html</u>

#### Socialist governments with tyrannical dictatorships have ruled. People remained poor.

Literacy rates are far lower. Immorality and violence prevailed

3. It is said that the difference between American education before and after 1900 is that before 1900 the youth were taught to think (make up one's own mind based upon weighing all sides of an issue); whereas after 1900 they began to be taught only to learn (memorizing and then repeating back what the teacher says). What effect would this have on the student?



Without being presented opposing arguments from each side, the child is deprived

of the knowledge necessary to even attempt to think critically. When opposing

ideas are disallowed in the discussion, it is no longer a discussion but a dictatorial rant and free-

thinking slowly passes away.

4. Critical thinking requires truth to be injected into the discussion by allowing differing points of view to be introduced. When Biblical precepts are not allowed to be discussed, what results can be expected.

Truth is suppressed - silenced - buried. This is what politically - correct thinking is doing, not only in

America but throughout the world.

5. Explain why we conclude that Biblical precepts are vital to be included in the education of all.

For the reasons stated above. Without the truth of God as presented in Scripture, the world will be covered again

in darkness. Truth is called "light" in the Bible. Without the light of truth, we cannot discern good from evil,

right from wrong, wisdom from foolishness. Our minds will be closed and locked
