**Wholesale Terms**

**Net 30 Terms** are available for established stores with an acceptable credit record. There is a 1.5% per month interest charge for past due accounts.

**Credit Cards:**

We accept MasterCard, Visa, American Express, and Discover. A credit card authorization form is enclosed. We will ship credit card orders to pre-approved addresses.

**Prices:**

Prices are subject to change without notice.

**Shipping:**

All orders are shipped FOB our distribution center, Atlanta Ga. All orders are shipped UPS ground.

**Sales Tax:**

We are required by law to collect sales tax unless we have a completed and signed Sales Tax Exemption Form.

**Returns:**

If you have a problem or discrepancy with an order, contact our customer service department at 404-691-3990 within 5 business days. All returns must be authorized in advance, and must be reported within 5 business days of receipt of shipment. Credits for returns will be issued upon receipt and inspection of the merchandise. We are unable to accept returns of merchandise once it has been laundered or decorated. Merchandise returned is subject to a 15% restocking fee, issued at the discretion of Two Feet Ahead.

**Refused & Cancelled Orders:**

Our orders are manufactured on a custom basis and are non-cancelable. Any orders refused or unclaimed will incur a 15% restocking fee in addition to shipping charges. Returned checks for any reason are subject to a \$25.00 charge.
