

## **Refund policy**

### **Returns**

You can revoke Fjordson products, that you've ordered in our online shop within 14 days after receiving the order. Inform us about your revocation by filling out the contact form [here](#). Please send the products within 14 days to the following address:

Our policy lasts 14 days. If 14 days have gone by since you received the order, unfortunately we can't offer you a refund or exchange.

To be eligible for a return, your item must be unused and in the same condition that you received it. It must also be in the original packaging.

Non-returnable items:

Gift cards

To complete your return, we require a receipt or proof of purchase.

We can refuse repayment as long as we have not received the returned goods or until you have shown you have returned the goods, depending on which event occurs first.

We expect you to handle the order as well as the packaging with the utmost care during the first 14 days after delivery. If you want to return the goods as described above, you may only unpack or use them to the extent needed to assess whether or not you wishes to retain them. Returned goods may be tested, but not used. When returning the goods, you will also have to return all delivered accessories and – if reasonably possible – return the goods in their original condition and packaging as well as taking in account our instructions as listed below.

### **Refunds (if applicable)**

Once your return is received and inspected, we will send you an email to notify you that we have received your returned item. We will also notify you of the approval or rejection of your refund.

If you are approved, then your refund will be processed, and a credit will automatically be applied to your credit card or original method of payment, within a certain amount of days.

**Late or missing refunds (if applicable)**

If you haven't received a refund yet, first check your bank account again.

Then contact your credit card company, it may take some time before your refund is officially posted.

**Shipping**

You will be responsible for paying for your own shipping costs for returning your item.

Shipping costs are non-refundable.

Depending on where you live, the time it may take for your exchanged product to reach you, may vary.

If you are shipping an item, you should consider using a trackable shipping service or purchasing shipping insurance. We don't guarantee that we will receive your returned item.

**Warranty policy**

Your Fjordson watch is guaranteed against all manufacturing defects for a period of 2 years from the date of its delivery. During the guarantee period the repair will be free of charge for labour and parts, if the technical service accepts the defective part to be a result of a manufacturing fault. This guarantee will be granted only with the guarantee card and the purchasing documents.

The guarantee does not cover: damage to the crystal, winder, crown, pushers, battery, pushpins or watch band - except if the damage is caused during the delivery process; requests for replacement or reimbursement; damage being a consequence of normal wear and tear or caused by mishandling, accidents or misuse due to non respect of instructions for use and maintenance; cost of transport and all risks of transport related directly or indirectly to the guarantee of the product; repairs done and batteries replaced by a non professional watchmaker; damage or defect due to water infiltration after repair; any damage by inappropriate use, such as sharp knocks, extreme heat, cold or magnetic fields.

The watch resists immersion in water: swimming is allowed, but no diving. An annual control of the sealing gaskets is recommended. Make sure that the crown is pushed into place and that the crystal is in good condition before making any contact with water. Like any object, your watch is affected by dust, perspiration, pool and sea water. Clean your watch with a soft cloth. Never use hot water for cleaning. Have a professional watch repair service replace the battery. Always explicitly ask to check the water resistance. Keep records of all replacements and repairs.
