

**COMPETITION REGULATION - TERMS & CONDITIONS**

SUSPICIOUS ANTWERP 's competitions, giveaways & giveaway contests are organized by SSPCS GROUP BV located Rijnkaai 100 / 11, 2000 Antwerpen Belgium registered under the company number 0672.916.318. SSPCS GROUP BV is further mentioned as "SUSPICIOUS ANTWERP" or "the organizer".

These terms and conditions apply to any and all competitions, contests, giveaways organized by SUSPICIOUS ANTWERP, mentioned on the official Instagram and/or official Facebook of "Suspicious Antwerp", @suspiciousantwerp and/or the official website [www.suspiciousantwerp.com](http://www.suspiciousantwerp.com). These are the general competition rules of SUSPICIOUS ANTWERP. If for a competition there are special competition regulations, these general regulations apply in addition to the special regulations. In case of contradiction between these rules and the special competition rules, the special rules shall prevail.

By entering the competition to win, you agree to be bound by these terms and conditions.

Instagram or Facebook are not in any way affiliated, associated or involved in the competition. The promotion of the giveaway contest is in no way sponsored, endorsed or administered by Instagram or Facebook. We agree to use the Instagram and/or Facebook service to manage our promotion, we do so at our own risk.

**ELIGIBILITY**

Participants must be over the age of 18 on the day of their entry. SUSPICIOUS ANTWERP may ask, at any stage, to provide proof of age and/or identity, if relevant. SUSPICIOUS ANTWERP may exclude any participants who are not able to provide us with such proof.

Minors may only participate in a competition if they have the express permission of both parents or their guardian. If a minor participates in a competition, SUSPICIOUS ANTWERP assumes that he/she has the permission of his/her parents/guardian. If the minor is unable to present this consent, he/she can at any time be denied further participation in the competition or have his/her right to a prize taken away.

Each personal profile (social media) or natural person (offline) can participate, when living in following countries: All EU countries, Australia, Canada, Great-Britain, Hong-Kong, Iceland, Ireland, Japan, South Africa, United States, South-Korea, Switzerland, Brazil, Indonesia, Taiwan, Israel, Qatar, Singapore, Sri Lanka, Thailand, India, Saudi Arabia, United Arab Emirates, Chile, Colombia, Costa Rica, Mexico, New Zealand, Peru, Sint Maarten, Uruguay, Venezuela, Egypt, Jamaica, Kuwait

Company pages, groups or profiles that do not comply with the rules of the social media channel will be excluded.

Not eligible to participate are persons employed by SUSPICIOUS ANTWERP as well as their respective family members and friends living under the same roof. Family up to the third degree of staff members and directors are also excluded from the competition. Nor can one the employees of SUSPICIOUS ANTWERP benefit from the prize or participate in the use of the prize.

**PRIZE**

The promotional prize shall be the SUSPICIOUS ANTWERP product as indicated on the specific competition, contest or giveaway announcement. The prize is as stated, no cash or other alternatives will be offered. The prizes are not transferable. Prizes are subject to availability, and we reserve the right to substitute any prize with another of equivalent value without giving notice.

The prize is limited to the "naked" prize as further described in the special competition regulations or otherwise. It can in no way be assumed that SUSPICIOUS ANTWERP would provide, or award additional services or products linked to the prize.

In the event that the prize includes the right to participate in a specific activity (such as an event, guided tour, etc.), the prize shall only include that right, unless stated otherwise. It is the organizer of the activity who must define all conditions. For example, he can ask to be present at a certain hour or a certain place, limit the access right in time. ## **HOW TO ENTER**

The announcement on the beforementioned channels explain the entry procedure. The criteria to enter are stated on the Instagram, Facebook, mail, LinkedIn or TikTok of SUSPICIOUS ANTWERP. There is no entry fee and no purchase necessary to enter.

**THE ENTRY**

**THE WINNER**

**SUPERVISION OF MATCH AND DECISIONS**
