



Order Processing/Routing Guidelines

To Our Valued Wholesalers and Distributors:

Please review carefully the following Shipping Guidelines for deliveries from our office and fulfillment warehouse.

Shipment Identification:

TanRawConcepts.com will clearly identify each carton and/or palette with the following information:

Carton Shipments

- A packing list with Tan Raw Concepts Inc./ TanRawConcepts.com P.O. number(s) will accompany any shipment without exception. This packing slip must be included on or in the Master Carton #1 if there is more than one carton. Master Carton is defined as the lead or first carton packed (if there is more than one carton) from one Purchase Order.

Pallet Shipments

- If a single pallet contains multiple SKU's, the pallet will be clearly labeled "Mixed Pallet", with case markings denoting the quantity of each mixed case for each individual SKU.
- If there are multiple P.O.'s on any pallet, each carton will be identified with the P.O. clearly marked.

Packing:

- Cartons will contain merchandise for only one purchase order.

- SKU's ordered by case will be shipped in original manufacturer cases with correct inner quantities.
- Merchandise will be packed in such a way as to prevent loss or damage in transit.
- Once order has been fulfilled and shipped all shipping information, tracking information, and invoices will be emailed to the contact email provided.

Shipping Carriers

- You have the option to use Tan Raw Concept's preferred carrier for all deliveries from our Distribution Center.
- Wholesaler/ Distributor will incur the cost of a shipment that is delivered via a carrier that is not a Tan Raw Concepts designated carrier.
- Designated carriers along with account numbers must be included with all Purchase Orders, If desired to use your preferred carrier.
- We conveniently ship with UPS, USPS, FED EX, and DHL

Shipping Dates / Cancel Dates:

- Shipments will be made no early than the ship dates specified on the Purchase Order and no later than the next business day.

Mis-Ships (Shortages, Substitutions, Add-Ons, Damages, Defective Products):

- Only items on the original P.O. that are received with defects or damages will be accepted for a full refund at Tan Raw Concept's expense.
- Any item shipped without authorization will be returned to Distributor at Distributors expense, unless otherwise agreed to.

Product Pricing

Tan Raw Concepts Inc. / TanRawConcepts.com to sell the products at the prices agreed and indicated on all approved purchase orders.

Customer Returns

Tan raw Concept's will honor all customer product returns of damaged and/or defective product made via TanRawConcepts.com within 30 day of customer receipt of product. Returns will be processed per Distributor's instructions and given a full refund.

Expired Product

Tan Raw Concept's will provide product according to the manufacturer's shelf life standards. Expired product will be returned for replacement product at Tan Raw Concept's expense.

Defective Product

Will be returned to Tan Raw Concept's for replacement, at Tan Raw Concept's expense. If a suitable replacement is not available, a credit will be issued.

Damaged Product

Tan Raw Concept's will be notified within one week of receipt of damaged product. Tan Raw Concept's will provide replacement product if available. If replacement product is not available, a credit will be issued.

Marketing and Advertising

TanRawConcepts.com agrees to market, promote, and otherwise make available the Wholesalers / Distributors contact information on TanRawConcepts.com

Wholesalers / Distributors shall provide the following:

- a JPG of the Brand Logo
- a high-resolution image of the Branding image (location image, or salon image)

- detailed contact information, such as; Name, address, phone number, email, etc.

TanRawConcepts.com will reproduce information as provided to TanRawConcepts.com by Distributor. However, TanRawConcepts.com reserves the right to edit any information submitted.

General

This Agreement contains the entire agreement between the parties and all prior arrangements between the parties and relating to the Products are superseded by this Agreement. None of the terms of this Agreement shall be waived or amended by either party unless such a waiver or amendment specifically references this Agreement and is in writing signed by the parties.

Payment Terms:

Tan Raw Concepts Inc. / TanRawConcepts.com will issue an invoice for all orders. All invoices will be sent to your contact e-mail provided, paid or for collection. COD terms are not a payment option to any Distribution Center. Distribution Centers shall be invoiced by Tan Raw Concepts Inc / TanRawConcepts.com. Distribution centers shall pay net thirty (30) days of receipt of invoice or net thirty (30) days upon receipt of product from Tan Raw Concepts unless other arrangements have been determined.

a. All changes to this Agreement shall be in writing and shall be effective when personally given or made or when transmitted electronically via e-mail or facsimile to the contacts at either TanRawConcepts.com or Tan raw Concepts Inc. as designated in the Agreement or to the other locations and individuals which either party may give notice to the other.

b. This Agreement shall be binding upon and inure to the benefit of the parties, their successors and assigns. This Agreement shall be assignable by either party with the written consent of the other or by either party without the consent of the other to the purchaser of substantially all the assets of its business to which this Agreement relates.
