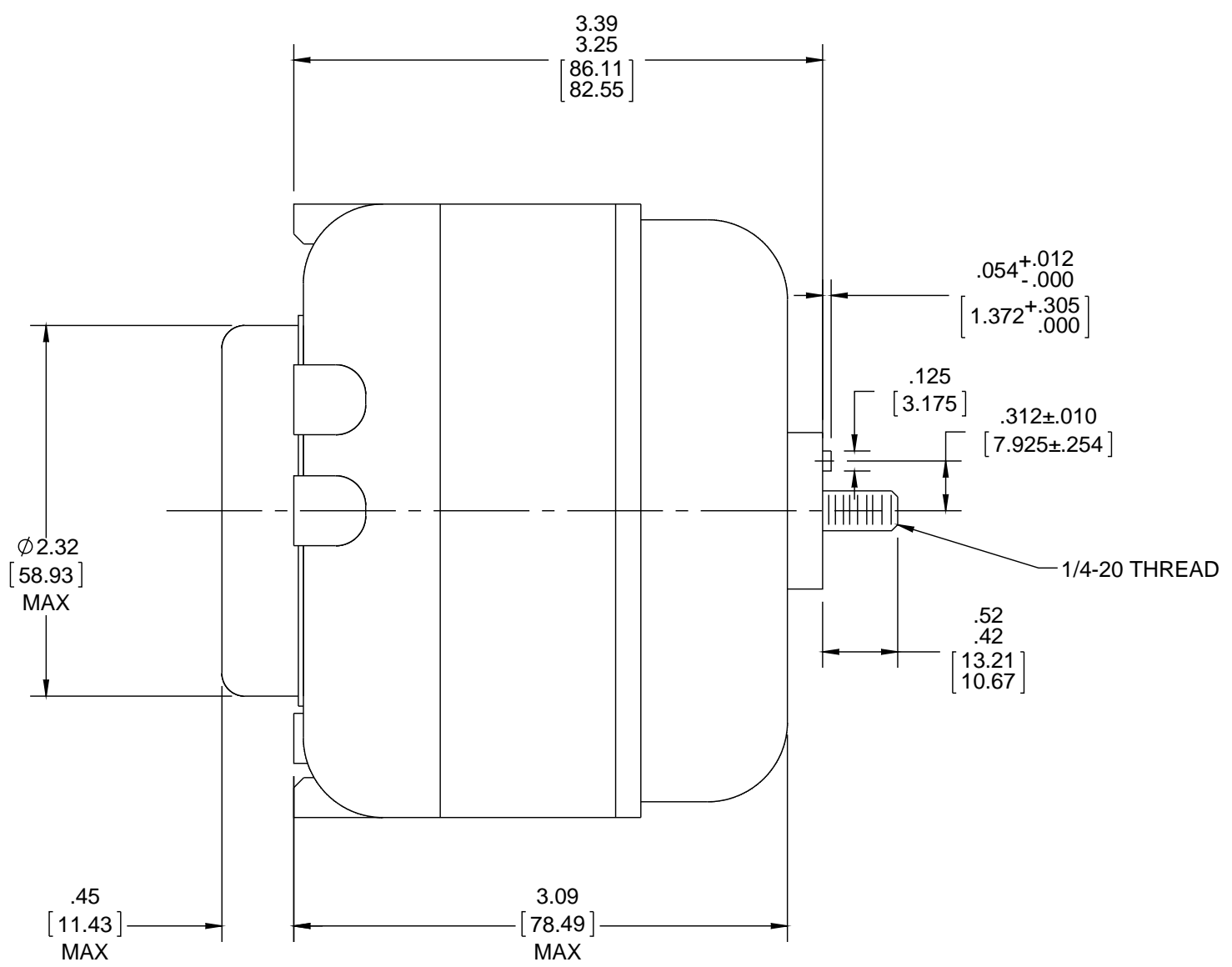


"M" MOUNTING
