**AFFIDAVIT OF JASON OESTREICHER REGARDING THE RAPID
REVERSAL OF HEMANGIOSARCOMA CANCER DUE TO THE

I swear that the following statements are true:


- I. My name is Jason Oestreicher and I live at 3233 Grant St., Hollywood FL. I have lived there for about 2 years.
