



## **Diesel Turbocharger Limited Warranty Statement**

***Before installing the turbocharger, make sure to read and understand the warranty statement found below. By installing the turbocharger, the purchaser, technician, or shop manager agree with the below warranty statement. If you do not agree in full, return the turbocharger in its original packaging for a refund. Contact us if you have any questions.***

Remanufactured turbochargers supplied by Turbo Parts Canada Inc. are warranted to be free from defects in materials and workmanship from the date of purchase to a period of:

1. 12 months for diesel motors in trucks, cars, and industrial applications.
2. 3 months for all powersport applications.

Turbochargers supplied from **Turbo Parts Canada** for diesel applications are **NOT WARRANTED** if used on modified vehicles, for competition purpose or in any other applications running more than manufacture specified boost levels. This warranty shall only extend to the original end user. Failure to install new oil feed lines when replacing turbo will void any and all warranty. Proof of such replacement must be provided.

Warranty for turbos is limited to repair or replacement by **Turbo Parts Canada** at **Turbo Parts Canada** exclusive option. Said warranty will not be honored in case of damage or malfunction due to improper installation, misuse, neglect, unauthorized disassembly or alteration or external physical damage. Also, said warranty will not be honored in case of (including but not limited to) insufficient oil pressure, foreign body ingestion, debris or oil contamination, overheat, above manufacture specified boost pressures. No warranty is made for any claims for special, indirect or consequential damages (including, but not limited to components removal or installation, equipment downtime, prospective profits, or other economic loss) due to any defect deemed otherwise warranted by **Turbo Parts Canada**.

All units returned to **Turbo Parts Canada** for warranty consideration must be shipped freight prepaid. Collect shipments will not be accepted. Purchaser must provide written notice of nature of the defect to **Turbo Parts Canada**. Purchaser must provide adequate means for operating and testing goods in question. Purchaser shall allow reasonable amount of time to remedy defect. Valid proof of purchase must accompany the returned product.

This statement represents the complete warranty offered by **Turbo Parts Canada** on its manufactured or remanufactured diesel turbochargers and related products expressly in lieu of any other warranties, including any of merchantability, or suitability for a particular purpose. No individual is authorized to bind **Turbo Parts Canada** to any diesel turbocharger warranty not expressly set forth herein.

Injuries, loss of income or any other loss or damages whatsoever, including those incurred in installation, repair or replacement as well as all incidental and consequential damages are excluded.

During this period, Turbo Parts Canada Inc. will repair or replace, at its option, any product that proves to be defective. Failure due to improper installation, abuse, poor maintenance, misuse or accidental damage shall be denied. Turbo Parts Canada Inc. shall be the sole adjudicator for all warranty determination.
