

### HOW MDADMIT WORKS:

Hello! I'm Dr. Miller, and I welcome you to MDadmit medical admissions.

I've been there. I understand how stressful the admissions process is and how unfair it often feels. I've felt that ball of stress in my stomach as I studied for the MCAT and USMLE, edited and re-edited my personal statement, battled with the dozens of secondary essays, and prepared for interviews, while never knowing if I was doing the right thing.

I've since been accepted into medical school, trained as an emergency physician, served as a Harvard pre-med tutor, gained experience as an admissions committee member, and, for many years now, worked as a medical admissions consultant helping thousands of people like you confidently apply and gain acceptance into med school.

My goal is to give you proven strategies: clear tactics and specific steps you can take to increase your chances of getting in. In fact, 99% of the people who follow my process get into med school and match in residency and fellowship – many of them into elite schools and programs, and even with merit scholarships.

Before we get started, I've found it is always helpful to discuss how MDadmit works to ensure we're all on the same page moving forward.

# ONE-ON-ONE SESSIONS

Before moving forward with any other á la carte services or packages, all clients need to start with a strategy session. If you are interested in other services or a package, we can discuss what is best for you in this initial session. This is why there are no Academic & Accomplishment Reviews + Strategy Sessions in the packages – because I need to meet you first! I want to ensure we are a good fit, and that you are ready to apply before moving onto a package.

It's very helpful to brainstorm a list of questions before our meeting, though this is not mandatory. I promise you will get more out of our session if you prepare beforehand.

My minimum meeting time, including phone and video calls, is 30 minutes.

I don't offer free initial consultations. I can't legally give advice until you are a client, yet, I am more than happy to chat about my services and if MDadmit is right for you. My number is 202-738-4353.

## EDITING

After you have completed the one-on-one meeting with me, you may want an essay, recommendation, or letter edit.

When you sign up for an edit, the scheduling program will ask you to choose a time (for one minute). This is a quirk in the system – it is not a meeting time but only necessary to log your edit request. However, you may use it as a good motivator to get your draft to me by that date.

You can either upload the draft to be edited on the website when you sign up for the service or send it to me via e-mail at info@MDadmit.com. If you ordered a package, you will send all documents to me via info@MDadmit.com.

### Please put your edits in the following format:

- **1.** Word .doc or .docx
- 2. Times New Roman 12 font
- **3.** Include word count of each essay or each section of the work-activities entries
- 4. Name file: [Your First and Last Names] PS1 or WA1 e.g. Suzanne Miller PS1 or Suzanne Miller WA1

Many clients purchase multiple editing services. The documents for edit can be sent together or in a staggered fashion – it is completely up to you and your work-flow.

### EDITING

The Personal Statement Editing and Work-Activities Editing services include a package of two edits. Every other type of edit, such as Secondary Essay Editing and Update Letter/Letter of Intent Editing, include one edit because of the speed required to turn these documents into the medical schools. If the secondary essay or update letter/letter of intent draft you send me is not ready for the first edit, I will let you know so we don't waste that edit on a subpar draft.

Secondary Essay Editing and Update Letter/Letter of Intent Editing services are charged at \$1/word. I also edit recommendation letters using the same fee structure.

All edits are returned in five business days or less. Rush edits are available at 1.5x the usual fee. Rush edits guarantee a 72-hour turnaround. Let me know if you'd like a rush edit, and I'll send a specific invoice.

Don't worry when you see lots of names in Word's track changes. This is because each draft is edited by both my editing team and myself. When you think about it, each "edit" is actually two or more edits. Over 20 years of working in medical school admissions, I've learned this process leads to the best end product.

# MOCK INTERVIEWS

You may also want to engage in mock interviews.

I perform all mock interviews via video conferencing, usually Skype, FaceTime, or Zoom. If you've purchased the video recording, Skype is the best option.

Multiple Mini Interview (MMI) and traditional interview preparation is available. We can practice both in the same session if desired.

The video recording is 100% worth it! It's very hard to take notes during the interview and even harder to remember all of my feedback by memory.

Prior to the interview, I strongly suggest reading my book, Nailing the Medical School Interview, available in hard copy on Amazon or as an ebook on my website. It will give you a huge head start leading into the interview and helps solidify the techniques I teach you during the mock interview. It is helpful for both traditional and MMI interviews.

If your suit is ready, I suggest wearing it for the mock interview so I can ensure it will work for the real interview day.

## ODDS & ENDS

I run a boutique admissions service with no more than 10 active clients at any time.

- I work with a wide range of clients, from high schoolers preparing to be pre-med to fellowship applicants. I have worked with clients ranging in age from 16 - 55 and have very likely worked with a client with a similar background and goals as yours.
- Once you have done a one-on-one session, you are officially my client. So you can ignore when my website says I'm closed to new clients.

I have no service or package minimums.

If a package doesn't meet your needs, just let me know. I create personalized packages for over 50% of my clients.

- It is perfectly fine if you want to add more services onto a package at a later time.
- I'm happy to answer very brief e-mails. But emails requiring greater than five minutes for response are charged at the hourly fee. Of course, I won't answer an email and spring a bill on you. I will let you know that I'll have to charge prior to answering so you can decide if I should move ahead with an answer.
