

## FIBERED ROOF & FOUNDATION COATING Data Sheet

**DESCRIPTION:** Gardner® Roof & Foundation Coating is a liquid applied, fibered, asphalt based coating. It is a low solvent formula, designed to penetrate and seal worn roof surfaces, foundation block walls, above or below grade and other masonry roof surfaces. Coating will weatherproof and help seal and protect surfaces. Can also be used to seal and protect underground wood footings and metal surfaces. Dries black in color. PREPARATION: Remove all dust, dirt, and debris. Patch all cracks or seams with Gardner Wet-R-Dri Roof Cement. Remove all rust or loose paint from metal surfaces. May be applied to slightly damp surfaces, but do not apply to wet surfaces or if rain is expected within 24 hours. Product can be coated with a reflective coating 7 days after initial application. On foundations apply only over cured concrete and masonry.

HOW TO APPLY: Use brush or paint roller to spread across surface.

**COVERAGE RATE:** This 5-gallon pail covers 350 sq.ft., per coat, over masonry and roof surfaces, depending on texture and porosity of surface. Two coats are recommended for best results.

CLEAN UP: Tools should be cleaned with citrus-based tar cleaner or water, when wet.

FOR BEST RESULTS ON ROOFS: After this coating has dried for approx. 2 weeks, apply a white or aluminum reflective coating for longest life expectancy.

PRECAUTIONS: Protective clothing and eyewear should be used during application of these products. When transporting this product, ensure that lid is tight and pail secure and upright. Do not allow pail to tumble as this may cause lid to loosen and leakage to occur. Do not transport on passenger seats or inside the passenger compartment of any vehicle. Store product in the cargo area of vehicle, and secure over protective cloths to prevent damage due to accidental spills. Do not store at temperatures above 100°F. This manufacturer also disclaims liability for flat surface application where poor drainage or ponding water may prevail. Do not reuse empty containers. Do not use in EPDM, Hypalon or PVC surfaces. Do not use on single ply or synthetic roofs. If there is any question regarding compatibility, test a small section first. Do not use in drinking water or food systems. Do not allow product to freeze.
