



Limited Warranty

Subject to the warranty terms below, this aquarium (or "product") is warranted by Crystal Dynamic Aquarium Manufacturing, LLC ("we" or "us") against leakage and/or coming apart due to defective materials or workmanship for 12 months from the date of purchase. If the aquarium is found to be defective and subject to the terms of this warranty, we will repair or replace the aquarium at no charge, or, at our election, refund the original purchase price. It is the responsibility of the consumer to return the defective aquarium to the dealer from whom it was purchased, or to the Crystal Dynamic facility (if purchased directly from us). Proof of date of purchase will be required. This warranty is non-transferable and is only available to the original buyer.

An extended limited warranty of 24 months from the date of purchase is given on aquariums purchased and used with a Crystal Dynamic stand.

WARRANTY TERMS

This warranty is limited to the original cost of the aquarium and does not cover any components or other loss such as livestock, aquarium contents, personal injury, property damage, loss of use, or other loss, whether direct, incidental, or consequential arising out of the use of the product. Our liability under this warranty only extends to the replacement of the tank.

All aquariums and related systems have an inherent risk of leaking or flooding. By purchasing and operating this product, the customer acknowledges and accepts this risk and the associated damages and loss. It is highly recommended that the customer obtain insurance to cover any damages that may arise in the event of an aquarium failure.

This warranty doesn't cover cosmetic defects not essential to the aquarium's structural integrity. The dealer/customer must inspect the aquarium upon receipt and report all cosmetic defects at that time; accepting the aquarium upon delivery implies approval of its visual appearance, and complaints about cosmetic defects submitted past that date will not be seen as a cause for replacement or refund.

This warranty is void: (1) if the aquarium is not placed on a strong level stand with a solid hardwood plywood deck specifically manufactured for aquariums; (2) if the floor on which the stand and tank are placed is not level or not properly supported; (3) if any structural elements of the tank are removed or altered; (4) if the silicone is removed or cut; (5) if the aquarium shows any damage due to impact, negligence, or mishandling, such as chipped or broken glass.

This warranty excludes damage resulting from accident, act of Nature, misuse, abuse, improper transportation or installation, lack of reasonable care, subjecting the product to any but the specified electrical service, and unauthorized service or parts. We are not responsible for any failure arising from improper use of the product, subjecting the product to abnormal working conditions or any other failure not resulting from defects in material or workmanship. Improper use and abnormal working conditions are thoroughly discussed in your User Manual.

In the event of an aquarium failure, Crystal Dynamic and the customer will take productive steps to determine its cause. This warranty will be void if the aquarium and/or the stand are moved from their original location before the cause of failure can be investigated.

To get this limited warranty, the customer must fill out the box below and submit to us within 90 days of purchase.
