ORIGINALITY POLICY

Only original works may be submitted. Any entry must be a concept entirely developed by the submitting artist and executed by his/her own hand. Duplications of another's work of art, whether by machine, hand or paint, is considered copyright infringement and may not hang in regular exhibits. Entries found not to be original will be excluded from the show and any awards revoked with no return of entry fees.

RELEASE & AGREEMENT

- Artwork must have been completed within the past three years.

DISPLAYING OF EXHIBIT WORKS

The Visual Art Center Exhibition Review Committee reserves the right to reject any work that is poorly presented and does not meet installation requirements. Artwork to be accepted must follow guidelines as established in exhibit "Guidelines for Exhibit" and/or prospectus for size, weight, framing and condition.

Publicity: All participating artists agree to allow the Visual Arts Center to use their artwork in advertising, in press releases, on our website, and in any other promotional activities. Care will be taken to give each artist proper credit.

Artwork must fit within pedestal or artist must provide own pedestal. Weight up to 35 pounds is acceptable. Over 35 pounds, the artist is responsible for placement of artwork with the approval of the Review Committee. Jewelry must be on stands that artist provides. Some jewelry may be placed in VAC case.
