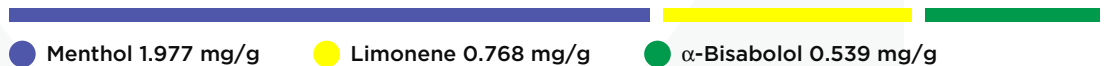

1 Menthol

Found in mint, sunflower, micromeria, mountain mint, rose geranium, pennyroyal, tarragon, savory, basil, juniper, couch grass, rhubarb, acinos (basil thyme), ironwort, muña...etc.

2 Limonene
 A monoterpene with a fragrance that can be described as orangey, citrusy, sweet and tart. It is most commonly found in nature as D-Limonene and is a primary contributor to the distinct scent of orange peels, from which it is commonly derived. Found in numerous pines, red maple, silver maple, aspens, cottonwoods, hemlocks, sumac, cedar, junipers...etc.

 A sesquiterpene alcohol with a fragrance that can be described as floral, peppery, sweet and clean. Found in chamomile, figwort, yarrow, skullcaps, lavender, ironwort, germander...etc.
