#### FILLING PIECES TERMS AND CONDITIONS

#### Identity and applicability

Www.fillingpieces.com ("Website") is operated on behalf of Filling Pieces B.V., having it's corporate seat at Spuistraat 168 B, 1012 VT, Amsterdam, The Netherlands, with Chamber of Commerce number 66962099 and VAT/BTW Number NL856771843B01 (hereinafter referred to as ("Filling Pieces/we/us/our").

These terms and conditions ("Terms and Conditions") govern and apply to your use of our website, all our offers of products on our Website and your acceptance thereof, and your purchase of products from our Website. These Terms and Conditions also govern and apply to all purchases made in our physical store(s). However, the sections "Return policy", "Right of Withdrawal", "Prices and payments" and "Deviations" of these Terms and Conditions are in its entirety replaced by the sections set out below in "Terms and Conditions for Products Bought in our Physical Store(s).

Please note that your use of our Website constitutes your agreement to follow and be bound by these Terms and Conditions. You can get a PDF copy of these Terms and Conditions by clicking the download button on your browser.

Please note that the term "you", "your" or "consumer" refers to the term consumers meaning a natural person not acting in the course of a profession or business, that consumes products as a customer or hands them over for repair to the entrepreneur.

The term "products" refers to products sold by Filling Pieces on this Website only.

#### Product availability and delivery

Although availability may be indicated on the Website, we cannot guarantee product availability and products, nonetheless, may not be available for immediate delivery. We reserve the right, without accepting liability or prior notice, to revise, discontinue, or cease to make available any or all products or to cancel any order. If there is any revision, discontinuance, or cessation, we may, in our discretion, ship products which have substantially similar functionality and specifications to the products ordered or cancel your order.

In accordance with the above, purchased products will be dispatched within 5 working days starting on the date of the order, however we try our best to dispatch the purchased products within 2 to 3 working days starting on the date of the order, excluding Force Majeure situations in the dispatching process.

Please allow up to 14 working days for delivery to arrive outside of Europe, and 7 working days within Europe. If you still have not received your purchased products after 3 weeks, please notify us via email at support@fillingpieces.com. You bear any and all duties and customs costs for orders shipping outside of the Netherlands and Europe. Please check our <u>FAQ</u> for the exact up to date delivery windows and our delivery windows during our online sale.

Where possible, we try to deliver all the products you ordered at the same time. Please note, however, that products may be delivered in separate shipments. We therefore reserve the right to deliver your order in separate shipments; for example, if part of your order is delayed or unavailable.

#### Colors

We have made every effort to display as accurately as possible the colors of our products that are displayed on the Website. However, as the actual colors you see will depend on your monitor, we cannot guarantee that your monitor's display of any color will be accurate. Therefore the pictures of our products on the Website are for illustrative purposes only.

#### Sizing of our products

The Filling Pieces shoes normally fit 0.5 to 1 size bigger compared to other brands. Please carefully check the Filling Pieces size chart on the specific product page on our Website.

#### Order process and agreement

You can only place an order if 1) you are a consumer, 2) who is at least 16 years of age, or has the consent of at least one of my parents and/or guardians place an order and 3) who provides us correct information

that is necessary for the fulfillment of the order.

An order placed by you is an offer to purchase the product(s) displayed on our Website, which offer needs to be accepted by Filling Pieces.

Once the order is placed by you, we will send you an order confirmation email, to let you know that we have received your order. This order confirmation email does not constitute an acceptance of your order or the conclusion of a contract. Filling Pieces reserves all rights to reject your order for any reason and with no liability to you or any third parties prior to Filling Pieces acceptance of your order.

Our acceptance of your order and conclusion of the contract will only take place when we send you an email confirming that your order has been dispatched. Please note that, prior to the dispatchment of your order, Filling Pieces may still cancel your order by reasons mentioned in these Terms and Condition, for example because of the unavailability of the product, your misuse, a force majeure event on our side or due to non-payment by you.

#### **Right of withdrawal**

As the consumer you can withdraw your order placed on this Website within 14 days after 1) the date you received the order or 2) if you have ordered several products in the same order, after the date you received the last product. Filling Pieces will honor your right of withdrawal, when notice of your withdrawal request is sent to Filling Pieces by using the <u>model form</u> for withdrawal or in any other unambiguous manner via email at support@fillingpieces.com or by contacting customer service, by calling +31 20 261 14 78, within the aforementioned 14 days.

Once you have notified us within the aforementioned 14 days, we shall reimburse within 14 days all the payments you made to us for the canceled order, including the delivery costs (if applicable and the maximum being the least expensive type of standard delivery we offer).

In the event that you have already received your products, you must return the products within 14 days as of the day following your withdrawal notice, in conformity with our return policy and at your costs. In that case we shall reimburse all the payments made for the canceled order, once we have received a proof of shipment or we have received the returned products. We will use the same means of payment that you used.

You are liable for the decrease in value of the product that is the result of you using the product in a manner beyond what is necessary to determine the nature, properties and functioning of the product. The risk and burden of proof for the correct and timely exercise of the right of withdrawal is on you.

#### **Prices and payments**

The prices displayed on the Website are quoted in Euros, including VAT and excluding delivery costs, if applicable. If delivery costs are applicable, they will be displayed during the checkout process. All prices include handling or taxes (total at the end) excl. shipping, if delivered to customers within Europe. For customers outside Europe, additional charges may apply.

Filling Pieces reserves all rights to 1) make changes to the prices displayed on the Website and 2) change or withdraw special offers or discounts at any time, without prior notice.

Filling Pieces only offers the payment methods displayed during the checkout process and Filling Pieces shall not be liable for any transfer or bank charges and/or import duties or taxes.

All payments are subject to authorization and validation checks done by the payment service provider. In the event that the payment service provider does not, for any reason, authorize or validate your payment, the relevant payment provider can notify you thereof, after which Filling Pieces shall cancel your order.

#### **Retention of title**

1) All products that have been delivered to you remain the sole property of Filling Pieces until you have fully paid any and all amounts owed to Filling Pieces under any contract that is placed between you and Filling Pieces, including payment of costs, earlier or later deliveries or partial deliveries. You shall remain liable for the devaluation of or damage to the product in the period between your receiving of the order and your payment.

2) Filling Pieces can exercise the right of retention when the consumer fails to fulfill a due and payable obligation, unless the shortcoming does not justify this retention.

#### **Return policy**

Our return policy entitles you to return the product(s) for any reason within 30 working days starting on the date you received the product(s) in conformity with our return policy. For orders placed during an online sale, the return period is 14 working days after the date you received the product(s), in conformity with your above mentioned right of withdrawal and our return policy. See our <u>FAQ page</u> and <u>FAQ Returns</u> for more information about our return policy.

You can open the package and check the contents. However, the products can only be returned when they are completely unused, unwashed or altered and sent in the original packaging, with original labels and double boxed. To return the product(s) fill in the return form, add it to the return box and attach the return sticker to the return box.

Filling Pieces shall not bear the costs of returning the product(s) unless otherwise indicated by Filling Pieces or its customer service in writing. This includes any costs associated with the return, including customs and other additional fees (for international shipments), these costs shall also be borne by you. It is your responsibility to keep all your return receipts, making a shipment by registered mail or by any other means necessary to enable a precise proof of the sending date and tracking of your return.

We only accept returns of product(s) purchased from this Website only. If you have purchased a product of Filling Pieces through one of our appointed distributors, please contact the relevant distributor.

If you are returning product(s) you may no longer qualify for any discount or special offer associated with your order. If you received any product(s) for free and/or any accessories with your order, you must return all the free product(s) and/or all accessories together with the product(s) you are returning to receive a full return refund or a digital gift card.

#### Exchange

In case of an exchange where you do not return the products from the initial order, we will charge you with the price of the products that were exchanged and not returned.

#### Returns From Outside the European Union

Please note that you must attach the commercial invoice of the package for orders being placed from outside of the European Union. The commercial invoice needs to be printed three times. One copy needs to be sticked on the package, one needs to be added inside the package, and the third copy needs to be handed in at the UPS drop off point. If you return your package from outside the European Union without the commercial invoice added as instructed, we can charge you with the additional return costs or deducted these costs from your refund.

#### Warranty ("Garantie")

1) Filling Pieces guarantees and warrants for one year from the date of purchase that the purchased products comply with the agreement (conformity) and that the products possess characteristics that, all circumstances considered, are necessary for normal use.

The following is not considered as normal use of Filling Pieces products and therefore not covered by our warranty:

- Using our products during sports or in extreme weather conditions.
- Excessive wear.
- Using any chemicals or sharp object on our products.

- Modification or repair of the product by you or any other third party, in any case if the shoe is no longer in its original condition.

- Neglecting or not properly storing our products.
- Poor maintenance and not following our wash & care instructions.
- Damages due to compression, a fall, abnormal impact or actions or wear against abrasive surfaces.
- Damages caused by UV (Sunlight or other natural phenomena), fire, bleach.

The following is not covered by the warranty:

- Natural breakdown of colors, finishes and materials over time / defects and wear to be expected with normal use, such as:

- Wear and tear, such as on soles and heels.
- Scuffed shoes or materials.
- Bleeding of any dye or discoloration.
- Damages due to perspiration.
- Wear and tear of accessories / decorations, such as zippers.
- Effects of moisture.
- Effects of external heat.
- Damage due to shoes washed in the washing machine.
- Dried out material.

Filling Pieces determines whether the warranty applies and determines the method of repair or to (partially (depending on the number of months the product has already been in your possession)) refund the price paid for the product and / or shipping. If you ship the product to be repaired, replaced or refunded, it must be provided with packaging in which transport damage is not possible. The warranty applies without prejudice to the consumer's statutory rights.

2) Complaints concerning defects (non-conformity) in purchased product must be submitted to Filling Pieces by email to support@fillingpieces.com as soon as possible and no later than two months after discovery thereof. This email should clearly describe the complaint, your name and order number, including a clear photo of the defect. You must return the defect Product to Filling Pieces in accordance with the return policy together with the original receipt. Complaints without proof of purchase will not be processed by us. Filling Pieces will replace the Product that cannot be used properly as a result of a manufacturing defect, provided that the product is still available. If a product is not available and you don't accept a similar product (if possible), Filling Pieces will at its own discretion (partially (depending on the number of months the product has already been in your possession)) refund the price of the specific defect product or provide you a gift card for that amount. Note that complaints should always be made to the (online) store where the product was purchased, that party will handle and evaluate your complaint.

3) Note that in all cases Filling Pieces is not liable for defects or resulting damage that have occurred after the delivery of the products as a result of incompetent / not normal use or lack of care, or that are the result of changes or repairs that you or a third parties have made to the delivered products or after one year from the date of sale as set out in this article.
