Completing your profile

Complete your profile and get verified — a step that's required before you apply to brands.

- 1. Starting at the top of the list, select "Complete your profile and get verified"
- 2. Create your public profile (this is what brands will see when they work with you)
- 3. Submit business information (this determines how you get paid)
- 4. Find a Brand (browse and search to find companies you want to work with)
- 5. Submit your Bank Account information, click "Setup"

Notification settings

Impact notifications keep you informed about events happening in your account. Set them to your desired specifications and you'll never miss a beat.

STEP 1

Configure your notifications:

- Notification frequency (i.e., daily, weekly, or monthly)
- Mobile device via SMS
- Custom notifications (i.e., click performance, account balance, etc.)



STEP 2

Modify notifications:

- On the left navigation bar, select the bell to view your notifications
- Select the gear (top right corner) to edit notification settings
