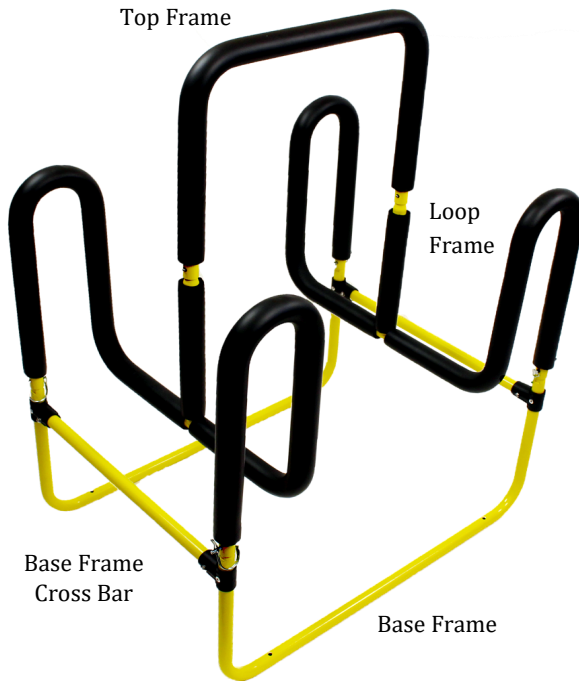


DOUBLE-UP SUP STAND Model # 22-9936



PARTS LIST	
Qty	Name
2	Base Frame
2	Base Frame Cross Bar
2	Loop Frame
8	Locking Pin
1	Top Frame

Holds up to 150 LBS

Assembly

Step 1: Assemble Stand

Parts Needed: 2 *Base Frames* and 2 *Base Frame Cross Bars*, 4 *Locking Pins*

1. Insert the *Base Frame Cross Bar* into bracket of *Base Frame*.
2. Line up holes and insert *Locking Pin* and secure on other side.
3. Repeat with 2nd *Base Frame Cross Bar*.
4. Attach 2nd *Base Frame* to the *Base Frame Cross Bars*.



Caution: When closing the Locking Pin, use the palm of your hand to lock it into place.

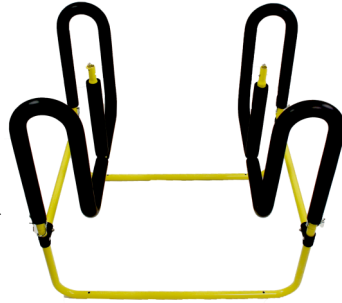

Step 2: Assemble Loop Frame

Parts Needed: 2 *Loop Frames*,
4 *Locking Pins*

The "Stand" sticker faces outward when positioning the Loop Frame. Insert the *Loop Frame* onto posts of base as shown. Secure with *Locking Pins*. To align holes you may need to gently tap upwards on the *Loop Frame* until the holes are fully aligned.



Step 3: Attach Top Frame

Parts Needed: 1 *Top Frame*

Loosely set *Top Frame* on *Loop Frame*. Push in *Push Pins* on both sides of post and snap *Top Frame* into place.
