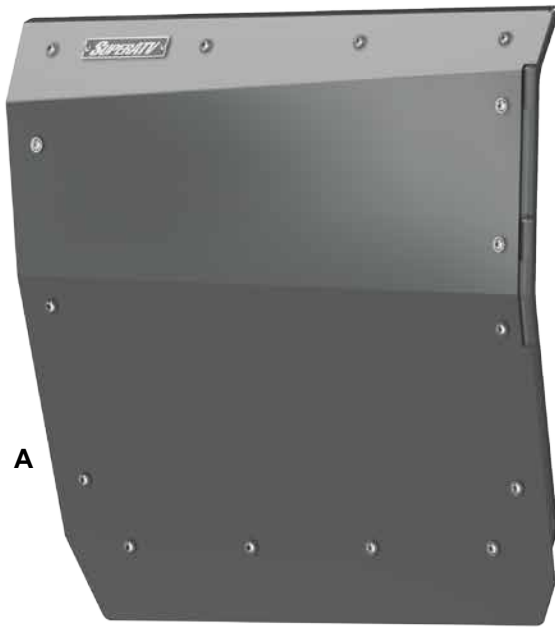
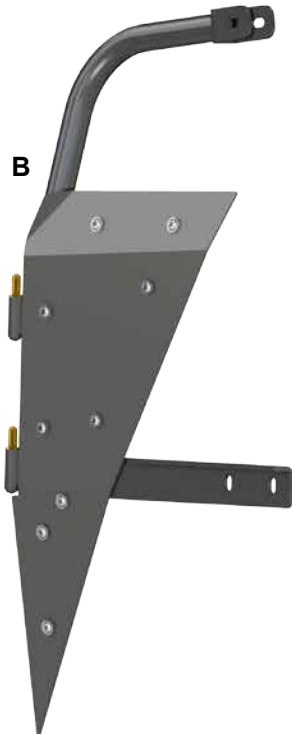

- Replace stock hardware with hardware shown; tighten.



- Install Filler - L (B) to machine with hardware shown; do not tighten.



- Place Door - L (A) onto Filler - L (B).



- Close and latch Door. Tighten all hardware.



- Repeat steps for passenger side installation.
