


INSTALLATION INSTRUCTIONS

Doors: for Polaris RZR XP® 1000



Door Cleaning:

- Do not use Rain-X®, Plexus® or any other protector, wax, or polish.
- Do not use window cleaning fluids (Windex, 409, etc) or any solvents (gasoline, denatured alcohol, acetone, etc).
- Never use abrasive cleaners, abrasive pads, or gritty cloths.
- Never use razor blades, scrapers, squeegees, brushes, etc.
- 1. Thoroughly rinse Doors to float off dirt and mud.
- 2. Using a soft cloth, or microfiber cloth, clean Doors with warm water and a gentle detergent. Baby shampoo, rubbing alcohol, or hand washing soap can also be used.
- 3. To prevent water spots, use a chamois to blot Doors dry.



SuperATV SP-P-RZR1K Side Panles must be removed








Reinstall Side Panel.







- Install Foam to Left Window Bracket in location shown.

- Install Hinge Bracket Left to Left Window Bracket with hardware shown; do not tighten.




- Install Left Top to Left Window Bracket with hardware shown; do not tighten.







- Install Upper Left to Lower Left with hardware shown; tighten.



SuperATV Roof: Place assembly and SuperATV Roof onto machine. Secure with hardware shown; do not tighten.


OEM Roof: Place assembly onto machine and secure with hardware shown; do not tighten.





- Install Clamps to Left Window Bracket with hardware shown; do not tighten.






- Replace stock Striker with Left Striker. Reuse stock plastic Shim and bolts.



- Remove Door hardware shown and install Strap. Reuse Door hardware; tighten.



- Install Gasket to Left Window Bracket.
- Install Strut with hardware shown; tighten.



- Close Door and engage Latch.
- Align Door to machine and tighten all hardware.

- Install D-Seal to Cage.
- Repeat for driver side.
