









Do not tighten hardware completely unless noted.

- Secure Door to stock location with hardware shown.
- Close and latch Door.
- Align Door to machine and tighten hardware completely.




### 2015 Viking models only:

- Remove Nuts from Latch Assembly.
- Install Bumper Plate and secure with Nuts previously removed.
- Install Bumper and M8 Jam Nuts as shown.
- Tighten hardware completely and repeat steps for opposite side.



- Bolts on Latch Assembly may interfere with factory Latch. Flip bolts over as shown.




#### **Latch Adjustment**

- Door may not latch if Cable is too tight.
- Door may not unlatch if Cable is too loose.
  - Loosen Set Screw.
  - Close Latch.
  - Adjust Cable slightly.
  - Tighten Set Screw.
