






#### Windshield Cleaning:


- Do not use window cleaning fluids (Windex, 409, etc) or any solvents (gasoline, denatured alcohol, acetone, etc).
- Never use abrasive cleaners, abrasive pads, or gritty cloths.
- Do not use a windshield wiper blade or install a motorized windshield wiper
- Never use razor blades, scrapers, squeegees, brushes, etc.
- 1. Thouroughly rinse Windshield to float off dirt and mud.
- 2. Using a soft cloth, or microfiber cloth, clean Windshield with warm water and a gentle detergent. Baby shampoo or hand washing soap are recommended.
- 3. To prevent water spots, use a chamois to blot Windshield dry. IN-FWS-P-RZR-1K

### Cut and install Hood Seal to bottom of windshield as shown To ease installation, soak Seal in hot water before cutting or installing to increase flexibility.







- Remove stock hardware from Roll Cage.
- Install hardware shown.
- Repeat for opposite side.




- Install Spacers as shown.Secure Lower Windshield to previously installed hardware.



- Install provided Gasket to Lower Windshield.




- Install Handle and Support to Upper Windshield; hardware included with Handle.



## Extra hands will make Upper Windshield installation easier.

- Place Upper Windshield assembly onto Cage and secure Clamps with hardware included with Clamps.
- Engage Latch and align Windshield assembly to machine making sure that Seal, on Lower Windshield, is in contact with Hood.
- Tighten all hardware completely.



- Place Upper Windshield in open position and secure Gas Struts to Pivot Blocks with M8 Nylock Nuts.
