**Front Removal:** *Keep all components removed from machine.*

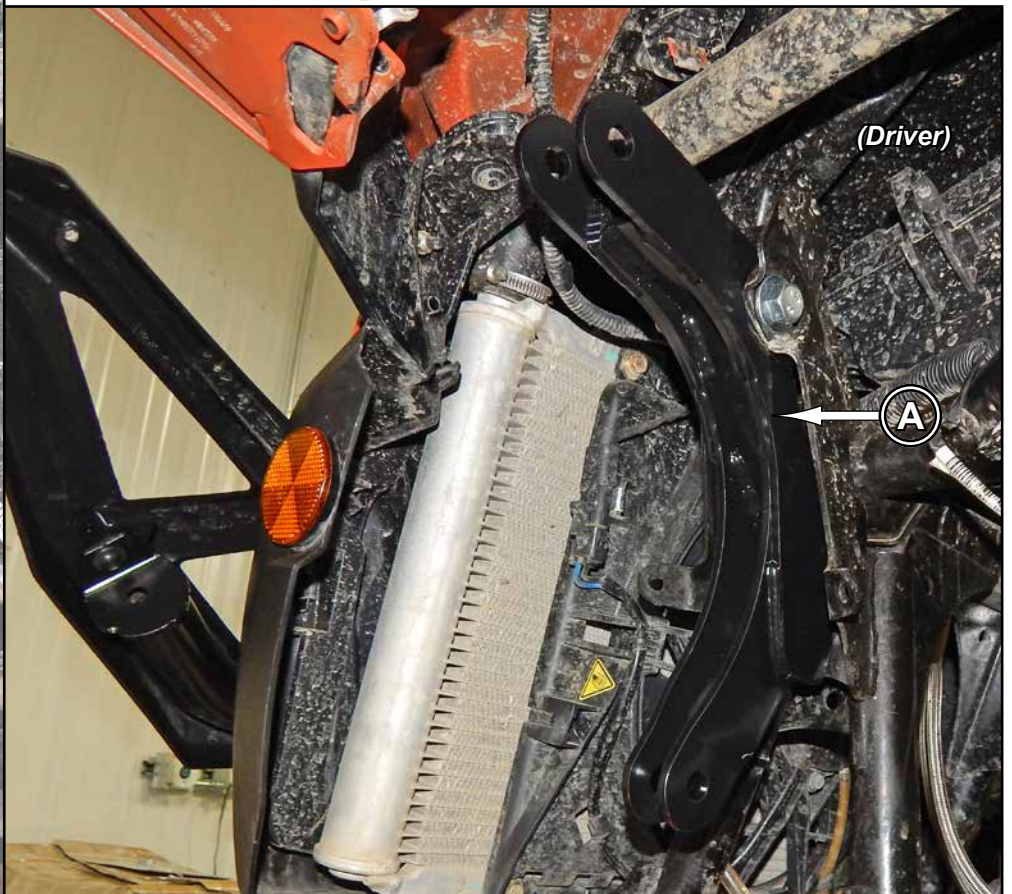
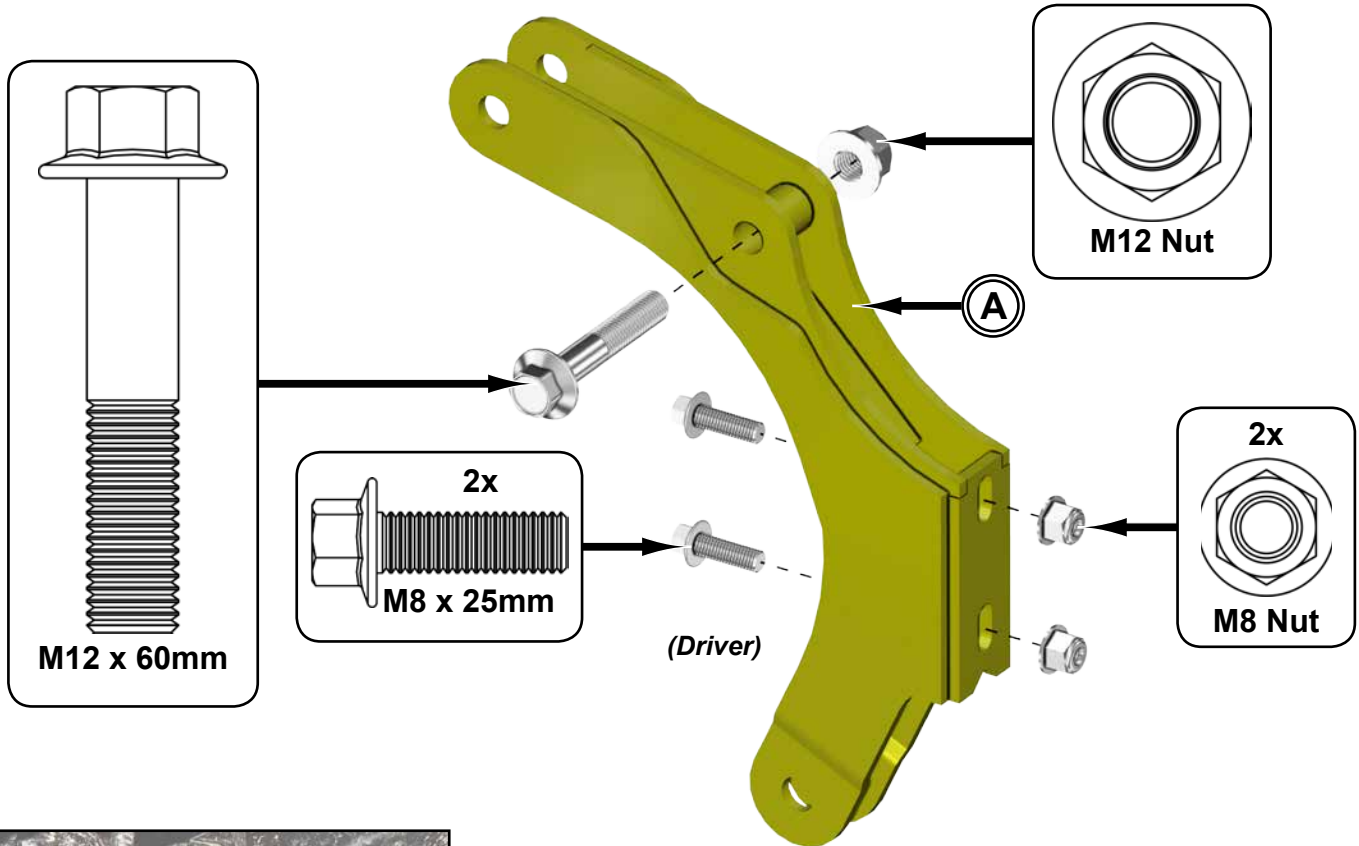


- Install Front Brackets (A) to Frame; See following page.



**Front installation:** *Do not tighten hardware completely unless noted.*

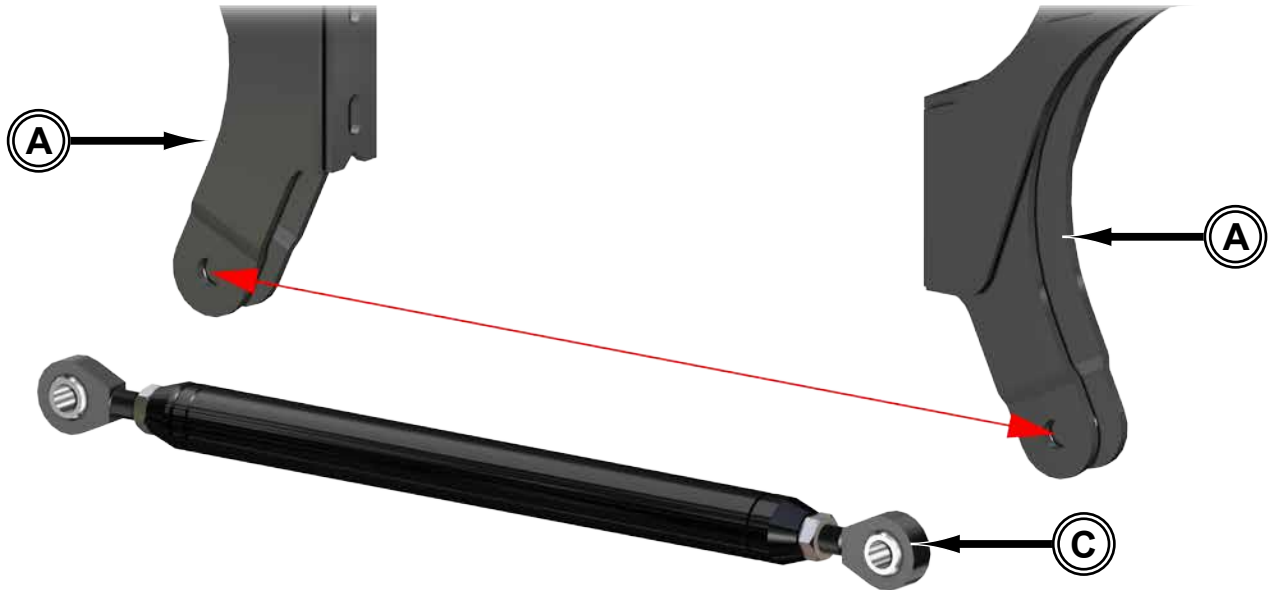
- Install Front Brackets (A) to Frame with hardware shown.
- Repeat for opposite side.

- Measure distance between Front Brackets (A) as shown and set Support Bar (C) to that dimension.
- Install Support Bar (C) to Front Brackets (A) with hardware shown.



**Tighten hardware completely.**

**Front installation continued:** *Do not tighten hardware completely unless noted.*

- Install Shocks to Front Brackets (A) with stock hardware.

**SHOCKS MUST BE ROTATED SO THAT RESERVOIR IS TO INSIDE OF MACHINE**

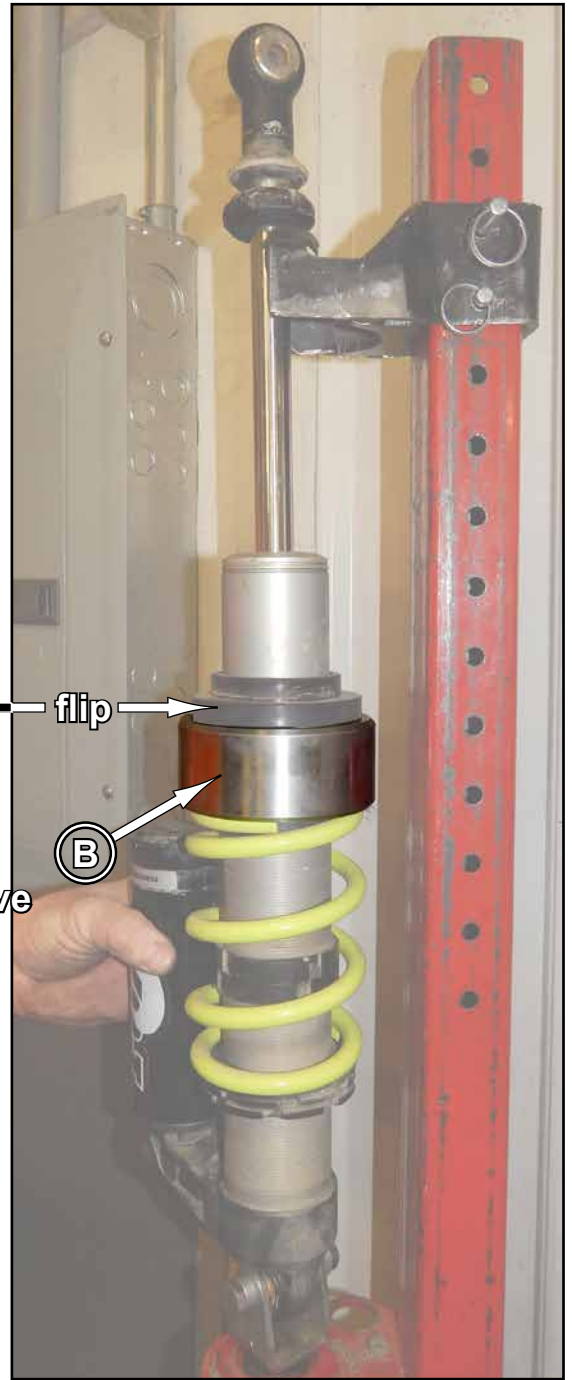
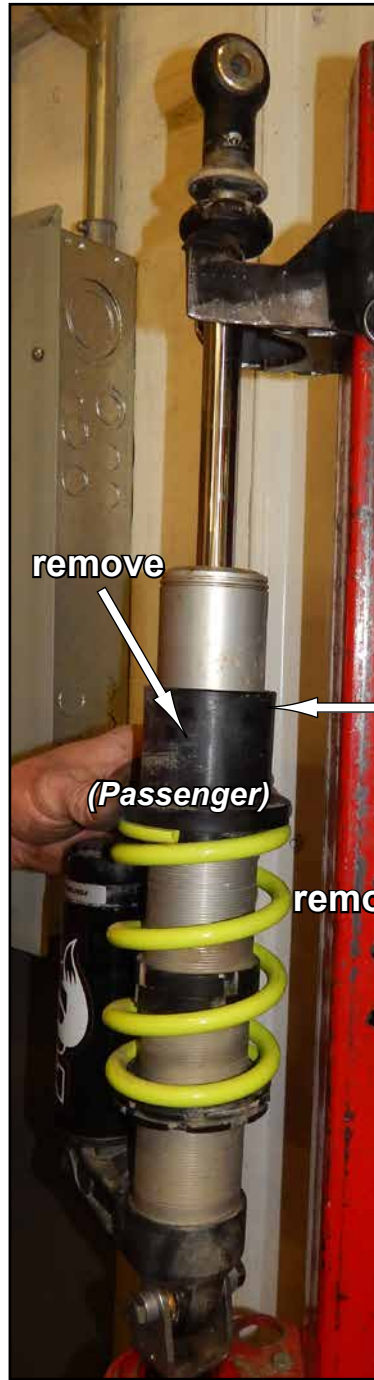
- Tighten hardware completely.



**Rear Removal:** *Keep all components removed from machine.*

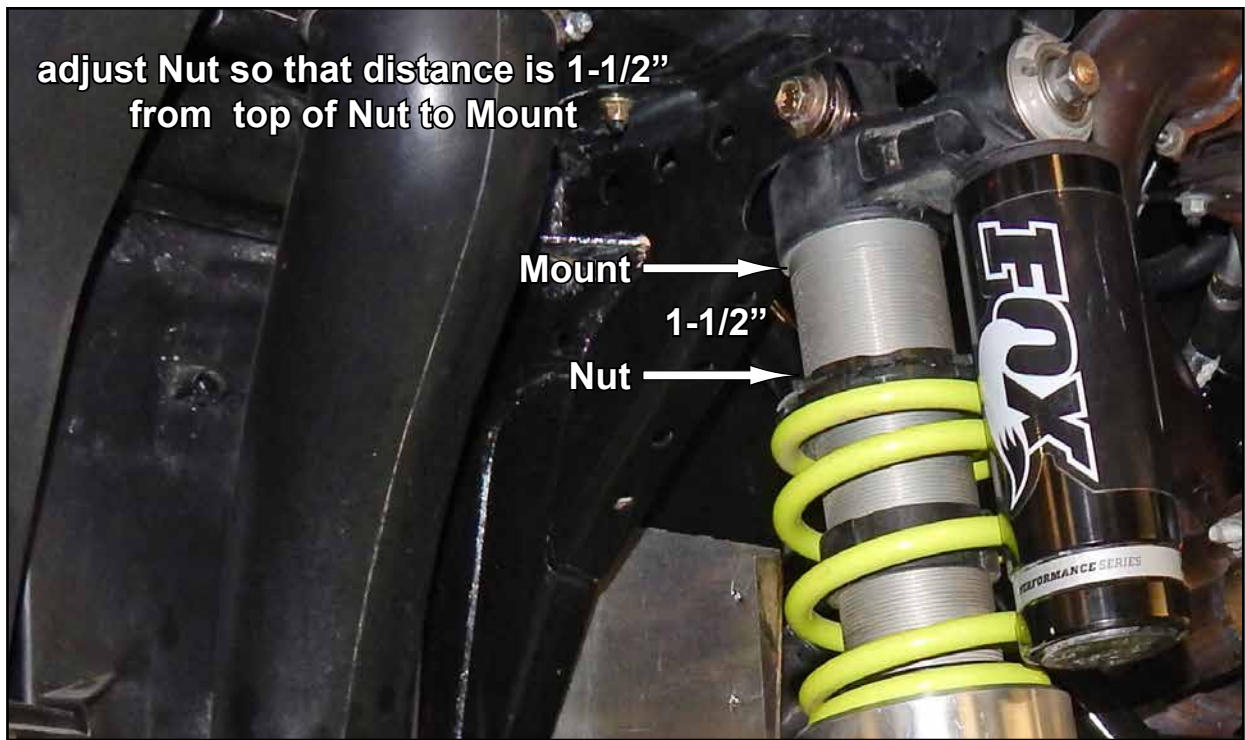


**SuperATV highly recommends using a Spring Compressor when removing Springs**
