

Do not discard packaging until product has been successfully installed.







*Connections

- Before installing, ensure that all Gaskets in electrical connections are properly seated.
- If Gaskets are not seated use a Flathead Screwdriver to seat.




On 600W Motor Connector, where arrow is pointing, is a small spring which needs to be slightly nudged up when plugging in.

Removal: Keep all components removed from machine.

























- Insert Lower Shaft (C) through Firewall and secure to Rack and Pinion with provided hardware.







- Install Lower Motor Mount (E) to Studs. Secure with stock Nuts; do not tighten.




- Install Motor (G) onto Lower Shaft (C); tighten.
- Secure Motor (G) to Lower Motor Mount (E) with hardware shown. do not tighten.



- Install Upper Motor Mount (A) to Motor (G) with hardware shown; do not tighten.
- Secure Support (F) and Upper Motor Mount (A) to Frame with hardware shown; do not tighten.




- Install Upper Shaft (B) into Tilt Assembly.




- Secure Upper Shaft (B) to Motor (G) with provided hardware; tighten.
- Reinstall Tilt Assembly with stock hardware; tighten.



- Tighten all hardware.



- Install ECU Mount (D) to Frame with hardware shown; tighten hardware.




- Plug Harness (J) into ECU (H) and Motor (G).

Secure in a visible location.




When activated, Diagnostic Light will flash once for about (1) second before turning off indicating proper function. Should different patterns occur, contact SuperATV.


