For this reason Colorificio San Marco constantly seeks to improve the quality of its products and their production cycles in order to reduce the overall impact on the environment and ensure quality and safety for customers.

This environmental data sheet shows the environmental information of DECORFOND: LCA, LEED and other information.

DECORFOND is a highly washable base product specifically developed to prepare indoor wall surfaces before the products VELATURE, PERLACEO, DECORI CLASSICI, CADORO, CADORO VELVET, ABC RIFLESSI, MARCOPOLO.

Formulated with an acrylic polymer-based binder, DECORFOND creates a film able to resist the alkalinity of plasters. Thanks to its particular formula it is able to perfectly even out the absorption of the support surface.

Thanks to its leveling powers, excellent opacity, good coverage and whiteness, DECORFOND is able to help attain the best results in terms of appearance and decoration.

#### LIFE CYCLE ASSESSMENT

Life Cycle Assessment (LCA) is a tool to quantify the environmental impact of a product or service throughout its entire life cycle. The LCA methodology, as defined by ISO 14040/44 [1-2], consists of four phases:

- goal and scope definition
- inventory analysis
- impact assessment
- interpretation

#### Goal and scope

The goal of this LCA [3] is to provide transparency about the environmental performance of DECORFOND, to create improvement options and support environmental communication. The functional unit is 1 kg of paint including packaging, with a spreading rate of 0.18 kg /sqm (average). The system boundaries include raw materials, their transportation, processing, packaging, distribution, use and packaging disposal. During the use phase the paint is hand-applied and the associated emissions are insignificant.


#### **Inventory analysis**

Primary data are used to the most significant processes, like the paint recipe, packaging and factory consumptions and emissions. Data refer to 2012 and are collected at the Colorificio San Marco's factory located in Marcon (VE). Secondary data originate from the ecoinvent v3 database [4]. The LCA calculations are performed with the LCA software SimaPro 8.0.3 [5].

#### Impact assessment

Life cycle impact assessment has been done with the method PCR product group: UN CPC 3511

**2014:5 on paint [6]**, as indicated in the EPD programme of the International EPD Consortium. This method consists of different environmental indicators including the Carbon Footprint, human toxicity, ecotoxicity, air emissions, water consumption and waste. Table 1 shows the LCA results.

#### Life cycle assessment verification

The LCA calculation system of Colorificio San Marco is verified by a third party in conformity with UNI EN ISO 11044:2006 and UNI EN ISO11040:2006 [7]

#### Interpretation

The LCA results indicate that the largest contributions come from upstream processes (i.e. raw materials). The Carbon Footprint of DECORFOND is  $1.853 \text{ kg CO}_2 \text{ eq}$ .

The negative values are caused by the pallet reuse.

#### **LEED**

**LEED** means Leadership in Energy and Environmental Design. It is a voluntary program that provides third-party verification of green buildings. It provides building owners and operators a tool to understand their building's environmental performance and to create healthy indoor spaces.

In order to obtain LEED certification, projects must satisfy prerequisites and earn points (there is a threshold). The number of points the project earns determines its level of LEED certification.

LEED is a certification system that deals with the environmental performance of buildings based on overall characteristics of the project. Although LEED does not certify products and services of individual companies, products and services do play a role and can help projects with credit achievement.

The table below shows DECORFOND potential contribution to the different **LEED credits** of the LEED 2009 and LEED v4 (Leadership in Energy and Environmental Design) [8]. Table 2 shows the possible contribution of the paint to potential credits, if used properly.
