NORMAL MOSS INFESTATIONS
 For normal control of moss, apply at the rate of four pounds per 1,000 square feet. A 20 pound bag covers 5,000 square feet.
HEAVY MOSS INFESTATIONS
 For heavy infestations of moss, apply at the rate of eight pounds per 1,000 square feet. A 20 pound bag covers 2,500 square feet.

STORAGE AND DISPOSAL
 Do not contaminate water, food, or feed by storage and disposal.
PESTICIDE STORAGE: Store this product only in its original container in a dry, cool, secured storage area.

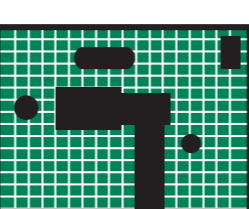
