1,2,3 Propanetriol, Glycerol, Cas# 56-81-5

**3. Hazards identification**

Health Hazards: No specific hazards under normal use conditions

Safety Hazards: Not classified as flammable but will burn

**4. FIRST AID MEASURES**

Inhalation: Remove to fresh air.

Skin Contact: Remove contaminated clothes, flush exposed area with water and follow by washing with soap.
