

CROWN & CALIBER SHARE YOUR WATCH STORY SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. YOU MUST HAVE INTERNET ACCESS IN ORDER TO PARTICIPATE. VOID WHERE PROHIBITED.

1. **PROMOTION DESCRIPTION:** The Crown & Caliber Share Your Watch Story Sweepstakes (the "Sweepstakes") is a social media Sweepstakes that begins on 05/06/2018 at 12:00:00 AM Eastern Time ("ET") and ends on 06/10/2018 at 11:59:59 PM (ET) (the "Promotion Period").

Throughout the Promotion Period, eligible entrants will have the opportunity to snap a photo of himself/herself (the entrant), another individual (provided their permission has been obtained), and a watch; and then share the photo in the form of a post along with your story in text on Facebook, Instagram, LinkedIn, and/or Twitter (the "Submission"), as more fully set forth below. For purposes of these Official Rules, a "Day" is defined as any 24-hour period beginning at 12:00:00 AM (ET) and ending at 11:59:59 PM (ET). There will be one (1) Grand Prize winner and thirty-five (35) Daily Prize winners. The Grand Prize winner will be randomly selected at the conclusion of the Promotion Period. The thirty-five (35) Daily Prize winners will be selected weekly during the Promotion Period still be eligible for the Grand Prize.

By participating in the Sweepstakes (as defined below), each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Crown & Caliber team ("Sponsor"), which shall be final and binding in all respects.

Submission must be posted to the entrant's non-private Instagram account; MUST include the Hashtags; and must be approved by the moderator to be eligible as an entry into the Sweepstakes. You must be a registered Instagram member to enter via the Instagram method of entry. Instagram account registration and Sweepstakes entry is free.

- c. LinkedIn Entry. You may enter the Sweepstakes via LinkedIn by going to <https://www.linkedin.com>, log into your LinkedIn account and post your Watch Story Submission along with the Hashtags. After entering your Submission, it will be moderated (per the "Submission Requirements" below) by the Sponsor before being visible on the Watch Stories page (<https://www.crownandcaliber.com/pages/watch-stories>). Submission must be posted to the entrant's non-private Instagram account; MUST include the Hashtags; and must be approved by the moderator to be eligible as an entry into the Sweepstakes. You must be a registered LinkedIn member to enter via the LinkedIn method of entry. LinkedIn account registration and Sweepstakes entry is free.
- d. Twitter Entry. You may enter the Sweepstakes via LinkedIn by going to <https://www.Linkedin.com>, log into your LinkedIn account and post your Watch Story Submission along with the Hashtags. After entering your Submission, it will be moderated (per the "Submission Requirements" below) by the Sponsor before being visible on the Watch Stories page (<https://www.crownandcaliber.com/pages/watch-stories>). Submission must be posted to the entrant's non-private LinkedIn account; MUST include the Hashtags; and must be approved by the moderator to be eligible as an entry into the Sweepstakes. You must be a registered LinkedIn member to enter via the LinkedIn method of entry. LinkedIn account registration and Sweepstakes entry is free.

Direct any questions, comments, or complaints regarding the Sweepstakes to Sponsor, not Facebook, Instagram LinkedIn or Twitter. Limit one (1) entry per person, per Day in the Sweepstakes - regardless of method of entry.

4. **WINNER SELECTION AND NOTIFICATION:** One (1) Grand Prize winner will be randomly selected from all eligible entries received during the Promotion Period on or about 06/11/2018 by Sponsor or its designee, whose decisions are final. Any potential Grand Prize winner will be the entrant of the Submission that is associated with an entry that is randomly selected as a winning entry, subject to eligibility verification. Potential Grand Prize winner will be notified via direct message within seventy-two (72) hours of the random drawing with instructions on how to verify eligibility and claim the prize using contact information provided or collected at the time of entry. Sponsor shall have no liability for any Grand Prize winner notification that is lost, intercepted or not received by the potential Grand Prize winner for any reason. If, despite reasonable efforts, a potential Grand Prize winner does not respond within two (2) business days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential Grand Prize winner, such potential Grand Prize winner will forfeit his or her prize and an alternate Grand Prize winner may be selected.
