

# ONE-YEAR LIMITED PRODUCT WARRANTY

Your Breville® product is covered by a one-year limited warranty from the date of purchase. Should your Breville product have a defect in product material or workmanship within the first year of purchase, Breville will arrange to have your original product returned to us, and deliver an identical or comparable replacement to you, free of charge.

## DO NOT RETURN PRODUCT TO THE STORE\*

Please follow these instructions to receive faster service:

1. Note the product model number and batch code (this is a 3 or 4 digit number). These numbers are usually located on the back or underside of the product, either on a sticker or an imprinted graphic.



2. Have the original or a copy of the sales receipt.
3. Contact Breville.
4. If the product, or one of its parts, qualifies for replacement or service under the Warranty, Breville will send a pre-paid shipping label via email so that the product may be sent to Breville at no cost to you. Upon receipt of the product, Breville may ship the replacement or contact you with further information regarding repair of the product.

Typical turnaround time to address Warranty claims is 10-14 business days, plus shipping, depending on your geographical location and type of damage or Warranty claim.

5. For additional protection of the product and secure handling while a product is being returned for any Warranty repair, Breville recommends that you use Breville's shipping label or a traceable, insured delivery service. Breville is not responsible for any damage while a product is in transit or for products shipped that are not delivered to the designated Warranty Consumer Service Center.

# BREVILLE® MASTER ONE-YEAR LIMITED PRODUCT WARRANTY

## INTRODUCTION TO THE LIMITED PRODUCT WARRANTY

For the purposes of this Warranty, as defined below, please note the geographic territory to which such Warranty is applicable, as defined below:

"Breville" as used herein, shall mean either Breville USA or Breville Canada, as applicable to the Jurisdiction (as defined below) of original purchase of the product for which Warranty Service is being sought.

"Jurisdiction" shall mean either:

- (i) the fifty United States and the District of Columbia only, not including any other U.S. territories, commonwealths, possessions or protectorates ("USA"), or
- (ii) a province or territory of Canada ("Canada"), together with the USA, collectively referred to as "North America", in each case, as applicable to the consumer purchasing Breville Products (as defined below).

## TERMS OF LIMITED PRODUCT WARRANTY COVERAGE

Breville provides the limited Product Warranty coverage as further described below and limited to the terms and conditions hereof:

1. Breville hereby provides a limited non-transferable Product Warranty for one (1) year from the date of purchase of the subject Product (the "Warranty") against defects in Product materials or workmanship. This Warranty is offered on those Breville brand appliances (each, a "Product"), purchased and used in North America by the consumer and is the sole and exclusive Product Warranty provided by Breville in North America.
2. The Warranty commences on the date of Product purchase in North America by the consumer and ceases on the 1 year anniversary date of such Product purchase ("Warranty Period"). A Proof of Purchase (as defined below) may be required by Breville from the consumer for the Warranty to be effective and applicable to the Product.
3. Proof of the valid Product purchase for the purposes of this Warranty ("Proof of Purchase") is an original or copy of the retailer sales receipt of the Product purchase or the retailer Product purchase invoice, showing the Product model number, payment and the date of the Product purchase. Product registration with Breville, while appreciated, is not required pursuant to the Warranty, and the Product registration is not a substitute for a Proof of Purchase.
4. In the event the Warranty Period for a Product has expired, or if a Product does not qualify for Warranty service, repair or replacement, consumers may still buy replacement parts or have Products repaired by one of Breville's Consumer Service Centers. Please contact Breville for further information.

## EFFECT OF THE PRODUCT WARRANTY

1. Within the Warranty Period, Breville may, at its sole discretion, either repair the Product with new or refurbished parts, or replace the Product entirely, either with a new or

refurbished Product at no additional charge to consumer. Breville may replace defective parts with any serviceable refurbished parts that meet the performance specifications of new parts for any applicable Product.

2. Only Breville or Breville-authorized accessories and replacement parts should be sought for use by consumer for any Product as the use of other non-Breville or non-authorized accessories and replacement parts voids any Warranty by Breville applicable to such Product.
3. All exchanged or substituted parts and Products replaced under Warranty service will become the property of Breville. Repaired or replaced Products or parts thereof will be warranted by Breville for the balance of the original Warranty Period or ninety (90) days from the date of Warranty service, whichever is longer.
4. In the event replacement parts or a replacement Product are not available for any reason at the time of the initiation of a Product Warranty claim by consumer, Breville may deliver to the consumer an accommodation in the form of a reasonably similar Product (an "Accommodation"), which such Accommodation to consumer shall be in full satisfaction of any applicable Product Warranty claim and of Breville's obligation to consumer under the Warranty for such applicable Warranty claim. The provision of an Accommodation by Breville to a consumer shall not be effective to extend the Warranty Period beyond such time as otherwise would be applicable to the Product replaced by such Accommodation.

## PRODUCT WARRANTY LIMITATIONS

1. Breville's obligation to the consumer with regard to the Warranty for any Product is limited to the repair or replacement of any defective Product or parts pursuant to the terms and conditions of the Warranty.
2. This Warranty is only valid for Products purchased and used in North America and shall not extend to any Products not purchased in North America.
3. The Warranty is not applicable to any purchase of a Product for commercial use (such as in a hotel, office, restaurant, or other business capacity).
4. This Warranty expressly excludes any defects or damages caused by accessories, replacement parts or repair service other than those that have been authorized by Breville.
5. No other warranties, express or implied, are made by Breville or are authorized to be made on behalf of Breville by any retailer, agent, distributor, or other party with respect to any Product to any consumer or other party.
6. The Warranty shall be rendered null and void, and of no further force or effect, providing no Warranty coverage with regard to a Product for each of the following, without limitation:
  - Products requiring maintenance or replacement due to normal wear and tear, corrosion, rust, stain, age or Products damaged due to any improper or discouraged use, mishandling, negligence, excessive wear and tear, including damages caused by maintaining, operating or using the Product in a manner not in accordance with or not contemplated by the instruction manual provided by Breville with the Product, or by otherwise failing to follow safety, operating, care or cleaning instructions;
  - Products where the model number or serial number has been removed, replaced, altered or rendered illegible;

- Products which have been altered, modified and repaired in any way not expressly authorized in the instruction manual provided by Breville with the Product or by any party not authorized by Breville as an authorized Warranty repair specialist;
- LCD or other read-out displays on Products attributable to non-manufacturer defects such as mishandling during transportation, drops, spills and extreme temperature;
- Cosmetic damages (examples include but are not limited, such as scratches, imprint/water marks, cracks and dents);
- Products that have been damaged directly or indirectly from the use of a third party product;
- Products damaged as a result of acts of nature, e.g. fire, flood, or lightning;
- Products damaged as a result of connection to irregular current or voltage sources, or use on electric or other current or voltage other than that marked on the Product, or any instruction manual;
- Products for which a consumer has no Proof of Purchase or for which the Warranty Period has expired;
- Products not purchased from Breville or through a Breville authorized distributor or Product reseller (for example non-authorized sellers online, at auction, or otherwise, such as, without limitation E-bay); or
- Products returned by the consumer to a Breville Consumer Service Center not using a Breville-provided shipping label which are lost or damaged in transit.

## WARRANTY DISCLAIMERS AND ACKNOWLEDGEMENTS

1. NONE OF BREVILLE, OR ITS PARENT OR OTHER HOLDING COMPANIES, SUBSIDIARIES, AFFILIATES, AUTHORIZED DISTRIBUTORS AND RETAILERS AND AUTHORIZED SERVICE PROVIDERS, OR ANY OFFICERS, DIRECTORS, AGENTS, OR EMPLOYEES THEREOF, SHALL BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL LOSSES OR DAMAGES (For illustrative purposes only, as examples, including without limitation, damages or losses from travel, lost time, perishable goods, damages for loss of revenue, business, profits, goodwill or contracts, business interruption, or any other pecuniary loss, any costs, expenses or other claims for compensation howsoever resulting from such loss), MALFUNCTION, OF ANY PRODUCT, OR ANY OTHER LOSS OR DAMAGE ARISING OUT OF ANY BREACH OF THIS WARRANTY FROM THE USE OF THE PRODUCT. WHETHER IN CONTRACT, TORT OR OTHERWISE, RESULTING FROM THE USE, OR MALFUNCTION, OF ANY PRODUCT, OR ANY OTHER LOSS OR DAMAGE ARISING OUT OF ANY BREACH OF THIS WARRANTY FROM THE USE OF THE PRODUCT. NOTE: Some Jurisdictions do not allow the exclusion or limitation for incidental or consequential damages, or limitations on how long an implied warranty lasts, so the foregoing disclaimer may not apply to those particular Jurisdictions.
2. IT IS UNDERSTOOD AND AGREED BY THE CONSUMER UPON PURCHASE OF A PRODUCT THAT, EXCEPT AS EXPRESSLY STATED HEREIN, BREVILLE IS NOT MAKING AND HAS NOT AT ANY TIME MADE ANY WARRANTIES OR REPRESENTATIONS OF ANY KIND OR CHARACTER, EXPRESS OR IMPLIED, WITH RESPECT TO THE PRODUCT, INCLUDING BUT NOT LIMITED TO, ANY WARRANTIES OR REPRESENTATIONS AS TO MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
3. THE CONSUMER ACKNOWLEDGES THAT THE CONSUMER IS INFORMED AND IS AWARE OF HIS/HER RIGHTS AND

OBLIGATIONS UNDER ANY APPLICABLE LOCAL MUNICIPAL AND JURISDICTION LAWS GOVERNING THE PURCHASE AND USE OF THE PRODUCT. THROUGH THIS WARRANTY, BREVILLE PROVIDES LIMITED AND SPECIFIED RIGHTS TO THE CONSUMER IN CONNECTION WITH THE PRODUCT. CONSUMERS MAY ALSO HAVE OTHER APPLICABLE RIGHTS WITH REGARD TO THE PRODUCT AND WARRANTY WHICH VARY FROM JURISDICTION TO JURISDICTION AND WHICH ARE NOT OTHERWISE SET FORTH HERE.

4. IF ANY PROVISIONS OF THIS WARRANTY ARE JUDGED TO BE ILLEGAL, INVALID OR UNENFORCEABLE, THE REMAINING PROVISIONS OF THE WARRANTY SHALL CONTINUE IN FULL FORCE AND EFFECT.

## WARRANTY CLAIM PROCESS

1. During the Warranty Period, if a Product, or one of its parts, qualifies for replacement or service under the Warranty, Breville requests that the consumer contact Breville's Consumer Service Center for further instructions on the Warranty claim process to address the Warranty claim, or repair and/or replace the Product or part.
2. Breville will send a pre-paid overnight shipping label via email so that the Product may be sent to Breville at no cost to the consumer. Upon receipt of Product, Breville may ship the replacement or contact the consumer with further information regarding repair of the Product. Typical response time to address Warranty claims is 7-10 business days depending on the geographical location of the consumer and type of damage or Warranty claim.
3. For additional protection of the Product and secure handling while a Product is being returned for any Warranty repair, Breville recommends that consumers employ Breville's shipping label or a traceable, insured delivery service. Breville is not responsible for any damage while a Product is in transit or for Products shipped by the consumer that are not delivered to the designated Warranty Consumer Service Center.

## WARRANTY NOTICE TO CALIFORNIA RESIDENTS ONLY

California residents may initiate Warranty service from Breville by calling the Consumer Service Center toll-free at 1-866-BREVILLE (1-866-273-8455), but California law also provides that for any Warranty Service for a Product, California residents have the option of returning the Product (a) to the retailer from which it was originally purchased, or (b) to another retailer that sells the same Breville Product, among other rights and consumer protections. California residents need only supply their Proof of Purchase, in each case above or to Breville, for Warranty service and should call the Consumer Service Center for specific instructions. Breville will only be responsible for the cost of the repair, replacement, and shipping and handling for such Products under any Warranty. A retail store to which a California resident returns a Product for Warranty Service may then repair the Product, refer the consumer to an independent repair facility, replace the Product, or refund the purchase price less the amount directly attributable to the consumer's usage of the Product. If the above options do not result in the appropriate remedy to the consumer, the consumer may then take the Product to an independent repair facility if service or repair can be economically accomplished. Breville and not the consumer will be responsible for the reasonable cost of such service, repair, replacement, or refund for the nonconforming Product if such Product is subject to the Warranty during the Warranty Period.

**TEN YEAR INDUCTION MOTOR  
SUPPLEMENTAL WARRANTY  
TERMS OF INDUCTION MOTOR SUPPLEMENTAL  
LIMITED PRODUCT WARRANTY COVERAGE**

Breville provides the additional limited induction motor warranty coverage on the BFP660/BFP680 and BJS600 as further described below:

1. Breville hereby provides a limited non-transferable induction motor (“Motor”) warranty for ten (10) years from the date of purchase of the Product (the “Motor Warranty”) against defects in Motor materials or workmanship. The Motor Warranty is offered on select Breville brand appliances (each, a “Motor Product”), purchased and used in North America by the consumer and, together with the Breville Master One-Year Limited Product Warranty, is the sole and exclusive Motor Product warranty provided by Breville in North America.
2. The Motor Warranty commences on the date of Motor Product purchase in North America by the consumer and ceases on the 10 year anniversary date of such Product purchase (“Motor Warranty Period”). A Proof of Purchase may be required by Breville from the consumer for the Motor Warranty to be effective and applicable to the Motor Product. The terms and conditions of the Breville Master One-Year Limited Product Warranty apply to the Motor Product for all matters not expressly addressed by the Motor Warranty.
3. The terms and conditions set forth in the sections of the Breville Master One-Year Limited Product Warranty titled “Effect of the Product Warranty”, “Product Warranty Limitations”, “Warranty Disclaimers and Acknowledgements”, “Warranty Claim Process”, and “Warranty Notice to California Residents Only” shall each be incorporated into this Motor Warranty by reference thereto and shall be applicable to the Motor Warranty and to the Motor Product as if set forth herein.
4. In the event the Motor Warranty Period for a Motor Product has expired, or if a Motor Product does not qualify for Motor Warranty service, repair or replacement, consumers may still buy replacement parts or have Motor Products repaired by one of Breville’s Consumer Service Centers.
