



## NOTICE TO POSTMASTER AND LAW ENFORCEMENT

Our company, Cali Steam LLC, specializes in the sale and distribution of hemp-derived products that are legal under the Agriculture Improvement Act of 2018 (commonly known as the 2018 Farm Bill). The products we handle contain only trace amounts of THC (tetrahydrocannabinol) within the legal limit of less than 0.3%.

We understand the importance of adhering to mailing regulations and cooperating with local, state, and federal authorities to maintain the integrity of the postal system and uphold the law. To this end, we are committed to providing accurate and complete information on all our shipments, including proper labeling and documentation, to facilitate smooth processing through postal services.

What is contained in our packages may look like marijuana or a marijuana product, it is **NOT**. The contents of these packages are legal industrial hemp flower products. The 2014/2018 US Farm Bill amended Sec. 297A of the Agricultural Marketing Act of 1946 which re-defined hemp and its legal status. This bill also amended Sections 102(16) and 202(c) of the Controlled Substances Act to establish hemp as a separate crop from marijuana and to establish that limited THC found in hemp is exempted from the Controlled Substances Act.

On February 7, 2014, President Obama signed the Farm Bill of 2013 into law. Section 7606 of the Act, Legitimacy of Industrial Hemp Research, defines industrial hemp as distinct from marijuana and authorizes institutions of higher education or state department's of agriculture in states that legalized hemp cultivation to regulate and conduct research and pilot programs.

In December of 2018, the 2018 Farm Bill was signed into law. It removed hemp, defined as cannabis (*Cannabis sativa* L.) and derivatives of cannabis with extremely low concentrations of the psychoactive compound delta-9-tetrahydrocannabinol (THC) (no more than 0.3% THC on a dry weight basis), from the definition of marijuana in the Controlled Substances Act (CSA).

Below outlines the amended acts that make the sale of our hemp products legal:

**Sec. 297A of the Agricultural Marketing Act of 1946** - "The term 'hemp' means the plant *Cannabis sativa* L. and any part of that plant, including the seeds thereof and all derivatives, ex-tracts, cannabinoids, isomers, acids, salts, and salts of isomers, whether growing or not, with a delta-9 tetrahydrocannabinol concentration of not more than 0.3 percent (<0.3%) on a dry weight basis."

**Sec. 102(16) of the Controlled Substances Act** - "The term 'marijuana' does not include hemp, as defined in section 297A of the Agricultural Marketing Act of 1946." Sec. 202(c) of the Controlled Substances Act is a table that previously had tetrahydrocannabinols listed as number 17 on the list of Schedule I substances. This entry has been amended and now reads: "(17) Tetrahydrocannabinols, except for tetrahydrocannabinols in hemp (as defined under section 297A of the Agricultural Marketing Act of 1946.)"

We kindly request your cooperation and assistance in ensuring the lawful and unimpeded transportation of our hemp-related products through the postal system. We are more than willing to collaborate with your office and law enforcement agencies to address any concerns, provide additional information, or implement any necessary measures to ensure compliance with the law.
