This allows holders of a producer's licence to sell their product at craft markets, farmers' markets, festivals and other promotional events.

RISK FEE

Determined by operating hours and compliance history.

Reducing operating hours or patron numbers may reduce this fee. Complete the relevant VCGLR form to make a free application.

OPERATING HOURS

The range of hours your licence/permit allows you to trade. Fees vary depending on trading hours.

INFRINGEMENTS/ PROSECUTIONS
