- 2. BUYER shall notify AMERICAN FIRE GLASS® of any defect within this warranty no later the thirty (30) days after a defect is discovered.
- 3. No product will be accepted for return or replacement without authorization by AMERICAN FIRE GLASS®. Before returning merchandise, contact AMERICAN FIRE GLASS® giving full details of the complaint, a copy of sales receipt, invoice or other evidence of purchase date, and an image of the item installed. Merchandise returned without proof of purchase date will be serviced out of warranty at our prevailing service and part rates. If merchandise is visibly damaged in transit, please refuse at time of delivery. If package was delivered without noticing damage, please notify AMERICAN FIRE GLASS® immediately so that we may file a claim with the carrier, . Product returned must be addressed as follows:
