A woman in Alabama took down - and then <u>reposted</u> - an entrapment incident on Facebook that allegedly occurred in a hot tub (spa) at a resort in Orlando, Florida. You can see the complete post - with multiple photos - by clicking the link.

If you still don't know what entrapment is, you need to educate yourself about this very real hazard. I wrote <u>an article for PoolPro</u> <u>Magazine</u> earlier this year arguing that non-fatal entrapments happen semi-regularly, but aren't tracked. This incident - along with the most recent <u>Consumer Product Safety Commission (CPSC) report</u> support this theory.

**What is entrapment?** Watch this excellent <u>7-minute video</u> as a good introduced. It was produced by the Association of Pool & Spa Professionals (APSP), now part of the <u>Pool & Hot Tub Alliance (PHTA)</u>.

### This information is not just for the operations team! Show this video to lifeguards, front line staff, management, health & safety, and even family members, where appropriate.

Read more about the <u>Virginia Graeme Baker Pool & Spa Safety Act</u> (<u>VGBA</u>). Similar and/or equivalent safety standards apply in most Canadian provinces and internationally in some countries.

And - if you think Paige's incident is an aberration - watch <u>this</u> <u>entrapment in North Myrtle Beach, South Carolina</u> from 2019 (viewer discretion is advised). The pump suction was so strong that two grown men could not remove the child until the pump was shut off.

For those looking to development a monthly entrapment checklist, look at <u>Alberta Health Services 2019 Anti-Entrapment Compliance</u> <u>Plan</u> as a possible template to start from. As always, if you need more individual support, please don't hesitate to hit reply to this email.

Not only that, I had NO idea that it was as powerful as it was. I was stuck there for a good 2 & a half to 3 minutes. The office staff and security manager were just as shocked as we were. The resort apologized & assured me the hot tub would be closed until they found a solution. The hot tub has not been taped off or closed since the incident.


Had my hair been sucked back into the skimmer, I would have drowned, right there in front of all of my friends & a few strangers. How traumatizing! Had this been a small child or an older person, they could have more injuries than I do.

The rest of my vacation was spent worrying about getting sucked into filters & skimmers & drowning.

It took us filing multiple reports to get a phone call back from the GM, who seemed to have brushed it off at first. GOOD NEWS, is that the GM went out with his Aquatic crew today to look at the hot tub to determine what the best solution is to this issue. Although this resort has been open for 19 years, they have never seen an issue like this (thank goodness) & plan to never see it again. I'm so very thankful that the GM is making sure this doesn't happen again.

I'm thankful that this ended the way it did & that I'm here to share the story, but I'm posting this in hopes it might save someone else's life.

Welcome to the early age of <u>Swimply</u>, an app featured on the TV show<u>Shark Tank</u> experiencing bonanza (2000%) growth during the COVID-19 Pandemic.

As a lifeguard and certified pool operator (CPO) instructor, I can think of nothing more dangerous than letting strangers into your residential swimming pool maintained at who-knows-what uninspected level of chemical balance or structural safety.

Kudos to the state of Wisconsin for pushing back against Swimplysomeone WILL get seriously hurt in a residential pool if there's not additional safety or operating requirements.

Those regulatory requirements don't need to be exactly the same as a Class A/Public Pool, but certainly more needs to be in place than the zero regulatory requirements after a residential pool is built.

"Wisconsin regulators told Swimply in April that pools offered for rent would have to be treated the same as large, public swimming pools. That means a pool's owner would have to obtain a license and meet construction requirements that are more onerous."

A runner's up award goes to <u>several municipalities in New</u> <u>Jersey</u> (free with subscriber registration) for taking a bylaw position and actually citing violators who continue to rent out their pools.
